Item 4. Discussion: ADA Transition Plan - Phase II Update

CDC Staff Michele Stokes, ADA Compliance Specialist, provided information on the status of the Tempe ADA Transition Plan, Phase II process:

- Phase II covers right of ways on arterial streets, 10 parks and 3 trails located north of Guadalupe, surrounding the Phase I Downtown area.
- Cost to repair Phase II elements is estimated to be \$38 million.
- Phase II data has been collected and summarized in a preliminary report.
- The 60-day Public Involvement Process (PIP) will facilitate comments.
- Presentations will be made to Commissions and Boards and city departments: Parks Commission, Transportation Commission, Tempe

- Accelerates (City departments and public), Community Development Site Plan Review team, etc.
- Presentations will be made to disability and senior organizations, including Apache ASL Trails (Deaf), SAAVI (Blind/Low Vision), Tempe Neighbors Helping Neighbors Board meeting (Seniors),
- After public involvement process, repairs will be prioritized and scheduled out through 2030 and beyond.
- Internal meetings are being held to streamline the workflow and funding.

Item 5: Tempe Beach Park Planning – Inclusive Parcourse Project

Chair Wendy Dietrich shared information on an Inclusive Parcourse Proposal. The Parcourse could be part of the Tempe Beach Park planning process. It would be located on the North side of the Tempe Lake. Material was shared that identified the need, barriers and presented the project as an option to "promote healthy community living" while maintaining existing open space that is accessible to all residents, ages and abilities.

Information was shared on inclusive equipment that would be arranged as a collection of individual exercise stations that are accessible to that would include opportunities for stretching, balance, agility and strength. Equipment could include lateral pulldowns, parallel bars, and a chest fly. It would be a great gym alternative. A "how to" sign would be at each station. Equipment would have options for everyone.

Ability360 and ASU Adapted Recreation, other organizations as well as Tempe Recreation would be the obvious programmers of the Parcourse, which would be open for public use as well.

The Commission made a motion: To discuss the Inclusive Parcourse Proposal further to determine the recommendation.

- The CDC/OSMD was successful in obtaining \$23,000 to install Hearing Loops from the Arizona Community Foundation. Induction Loops, which help people who use hearing aids and cochlear implants will be installed in Library Rooms A and the TLC. Funds will be sought to also "loop" the Library Meeting Room B and the Board Room.
