# Agenda Item 2 – Approval of Meeting Minutes

### Agenda Item 3 – Recap Previous Presentations

There was no presentation to be recapped or that needs clarification.

### Agenda Item 4 – Utility Rate Study Recommendation

Deputy PW Director Engineering Marilyn DeRosa, Deputy PW Director Field Operations Tony Miano, Deputy Internal Services Director Jerry Hart, PW Planning Resources Analyst Stephen White and PW Administration Manager Julie Hietter presented highlights of the Tempe multi-year utility rate study and staff recommendations identified through the process.

# The presentation included:

- Outreach and education for the solid waste, water and wastewater rate study included meetings with focus groups, City Council water conservation working group, public meetings, small group meetings with Mayor/Council, and HOA meetings
- Solid Waste Study:
  - Cost of service allocation
  - o Solid waste residential study objectives; goal 40% diversion by 2020
  - o Pricing parity for multifamily accounts
  - o Save Money and Recycle Tempe (SMART) pricing model and program rates
  - Commercial rates
- Water and Wastewater Study:
  - Single family residential
  - Flood irrigation
  - o Cost of service and existing single family rate structure
  - Monthly single family residential tier sizing
  - Peak usage and system peaking factors
  - Proposed single family residential tier pricing
  - Proposed flood irrigation cost recovery

Staff will present at City Council's work study session on September 7<sup>th</sup> and there will be City Council public hearings in October with an anticipated adoption date of January 2018.

Public Works Director Don Bessler said there is a city water conservation goal and there should be a slide in the PowerPoint that shows the goal; Don re-affirmed that the proposed rate plan still messages the importance of water conservation while honoring the notion that wise water use does not always equate to xeric landscaping.

Commissioner Jung asked if the commission should make a formal recommendation. Public Works Director Don Bessler said the Commission will have time to provide comments before the Council's adoption public hearings and that the Water Sub-committee could provide comments to the commission and the commission could pass comments and recommendations forward to City Council after hearing the sub-committees' thoughts. In general, the commission supported the approach.

### Agenda Item 5 - Water Subcommittee Updates

Public Works Director Don Bessler said the city does not have a multi-family water conservation goal and that the subcommittee should feel comfortable making a policy recommendation to council. The subcommittee could also review if the single-family conservation goal is adequate; and provide comments to Council for the rate study.

Commissioner Monty said the next Water subcommittee meeting is September 5<sup>th</sup> and that the subcommittee is coming up with framework of goals and objectives for the group.

### Agenda Item 6 – Retreat 2017

Chair Kane introduced the item. Carla Sidi recommended dates in September and all present agreed on Saturday, September 30<sup>th</sup> between 8:00 a.m. and 12:00 p.m. at the Eisendrath House

Potential topics for the retreat include:
