

Subject: Tax Revenue Statistical Report – June 2018


Attached is the Executive Summary of the Tax Revenue Statistical Report for June 2018 covering May sales activity reported to the Arizona Department of Revenue (ADOR). The lag in reporting is due to the delay in receiving information from ADOR.

The graph to the right depicts year-to-date General Fund historical privilege tax revenue from FY 2008-09 through FY 2017-18. Total taxable sales increased by 5.2% over the prior fiscal year. General Fund Sales Tax revenue is also up 5.1% (\$4.7 million) because of overall strong retail (\$3.7 million), rentals (\$2.4 million), and combined bed tax and hotel/motel (\$1.3 million) activity. The combined bed tax and hotel/motel tax revenue is up 12.8% as its trend has recovered from extra payments made during the prior year.



The graph below represents twelve months of activity, comparing current year General Fund monthly sales tax collections to the previous year.

Although sales taxes are not budgeted on a monthly basis, the graph below applies historical collection percentages to the annual budget to gain insight into sales tax performance. Using this approach, sales tax collections in the General Fund (excluding restricted bed taxes) are \$4.3 million above budgeted projections for the year.
