Item 7. Discussion: 2019 Disability Awards - Status Update

Sponsorships: \$250 has been received from former Commissioner Irene Mochel. Emails were sent out to prior sponsors and others. Sponsorship requests will be shared via social media in the next week or so.

Website: The website page is active. Nominations and Sponsorship information is available at www.tempe.gov/disabilityawards.

Marketing: Information will be sent out through Tempe's Public Information Office next week. About 100 emails were sent out last week to businesses and agencies. Please share information through your networks.

2020 Award Sponsorship application for student awards was submitted to the Tempe Diablos, for the same amount as requested previously: \$2,400.

Item 8. Discussion: 2020 Disability Awards- TCA Disability Art Exhibit

Inquiry on whether the art exhibit space could be used for the 2020 event was made and the space is booked out for 2020. However, if we want to use the lobby space, that may be a possibility, however it would compete for table space. Vice Chair Schmidt said she could check with Art Awakenings who showcase art created by individuals with behavioral health disabilities to see if they could manage a display in the lobby for 6-8 easels.

Commissioner Kent and Chair Dietrich said that perhaps Tempe Art Administrator Maja Aurora who coordinates city art installations may be of assistance. Questions to answer include whether there would be any extra costs and who would provide the easels, set up, etc.

Item 9. Discussion: Adapted Recreation / Parcourse

Adapted Recreation. City Council Aide II Parrish Spisz and Adapted Recreation Coordinator Samantha Mason provided an update regarding the Council Workgroup on Adapted Recreation. Surveys and research indicate that Tempe residents are most interested in inclusivity in all aspects of recreation. Plans are being developed to hire trained inclusivity staff and ensure that recreation catalogs and website include information on providing accommodations.

Current locations of adaptive programming are maxed out and there is a waiting list. Discussion was held on what inclusion might look like for Kid Zone, classes, programs and camps. Research regarding staff to participant ratios, accommodations processes, and coordination required to facilitate proactive inclusion is in progress. Tempe has some after-school and seasonal camps, Special Olympic programs that are adaptive, that are existing. These include growth and development, social/recreation opportunities, mental health and social recreation, training and more.

Commissioners were invited to attend a February 4th Public Hearing at 4 p.m. in Room A, in the lower level of the Tempe Public Library, on Adapted Recreation plans, being proposed.

Parks has developed a draft Inclusive Playground Manual to facilitate disability inclusion in new development and renovations of existing playgrounds. A copy of the draft was provided. Staff will make copies and distribute at the next meeting.

Parcourse. Chair Dietrich has been working with city staff in Community Development and Public Works, Parks per Strategic Management and Diversity Office Director Rosa Inchausti's direction. The Parcourse location can sustain the development. Water sources are available for restroom and drinking fountains, when developed.

There is room for accessible parking spaces and the nearest public transit stop is on Mill, Northbound, NE side.

The next step is to determine if funding can be facilitated in the five-year operating budget planning process for capital improvement programs, for future development.

Item 10. Discussion: Commission and Staff Announcements

Tempe's BEST Program Coordinator Dr. Max Ryser has been hired. A quarterly report will be shared with the Commission when its available.
