# Agenda Item 2 - Equity in Action

Chair Hermanns introduced Braden Kay to the Commission. Braden thanked the Commission for allowing him to present and introduced himself. He proceeded to give the history of the Equity in Action pilot program. He then informed the Commission that they are currently in the process of accepting applications for those interested in participating in the program. These individuals would receive \$25 per hour and would be expected to attend six, two-hour meetings. The goal is to have ten people on board that represent areas and/or groups that are currently underrepresented in the city. The expectation is these individuals would bring in members of the community they represent, to initiate a conversation with the City of Tempe. Braden then asked for the Commission's help in recommending individuals who they think should apply for this program. Braden also acknowledged that the application process is confusing and that both he and Rosa would be available to meet with anyone interested in applying and help them with the process. The Commission discussed and agreed to help get the word out regarding the program and will send any recommendations they have to both Rosa and Braden. The Commission thanked Braden for the presentation.
