# Item 3. Presenter: Council Member Robin Arredondo-Savage

Director Rosa Inchausti introduced Council Member Robin Arredondo-Savage, who discussed several areas that Tempe has worked on to increase disability inclusion:

**Parks.** In a workgroup with Parks, a recreational opportunities catalog was created to help standardize accessible park playground equipment. When playgrounds are replaced, they are made 100% accessible.

**Adapted Recreation.** In working with Adapted Recreation, we saw that their budget hadn't increased in 10 years and the programming was also the same. We worked to increase the budget and the opportunity to ensure everyone has an opportunity to request accommodations in all classes to participate and increased the budget.

**Social Inclusion**. In working with the prior CDC Chair Wendy Dietrich, discussions were held on how to provide better customer service and inclusion to people with disabilities in Tempe. We discussed: What are we doing well and what are we not doing well? What would Disability Social Inclusion look like? What would we need to do it right to get the right results? This boiled down to asking: What does inclusion look like? In developing this, we need to listen to residents and listen to Tempe staff, so we can better serve.

What's next? To obtain answers to decide what needs to be done, we want to go on a "listening tour;" first with employees and then with the public. We will start with a meeting or forum with 14 department heads and their frontline staff to discuss structures, accessibility, services and disability social inclusion.

We will invite Commissioners to attend. As soon as we have the date finalized, we will let you know. The meeting will be held in the Tempe History Museum Community Room.

In January 2020, we want to take the "Listening Tour" concept to the community.

In talking about inclusion, Commissioner Jeffrey C. Oats said that improvements in transportation needs to also be discussed. He related a recent Dial-a-Ride incident where the operator hadn't waited even 5-minutes, and was ready to leave, before he got out the door. He asked the operated to wait as he had to get his wheelchair off the battery charger. Then another when he had called in a cancellation and then got a call that afternoon, saying they would be picking him up from the location of the cancelled appointment. He said that the changes to Dial-a-Ride has led to some messy situations.

Council Member Robin Arredondo-Savage, who is now on the Valley Metro Board said she would see what she could find out about the situation.

**Director Rosa Inchausti** introduced **Jonae Harrison**, **JD**, who is the new Tempe Equity & Inclusion Manager. She previously worked for Chicanos por la Causa and is passionate about fighting for the most vulnerable in the community.

Discussion was held on a few areas of inclusion that have been instituted in the past year or so. These include access for recreation of people with disabilities the master plan for the Tempe Lake, and inclusion in the Urban Core Master Plan. The heart of it is that: Tempe is committed to disability social inclusion in our residents' quality of life.

# Item 4. 2020 CDC Priorities – Information for the Annual Report

The CDC's Annual Report will need to be voted upon at the next meeting. Discussion included the status of 2019 goals, and recommendations for the 2020 goals.

**Status of 2019 Goals.** The completion status of the 12 goals was shared. These goals align with City Council Strategic Priorities 3.13 Disability Social Inclusion and 3.14 ADA Transition Plan. Of the 12 goals, one was addressed internally, and two were not able to be completed to date. The 2019 goal areas focused on: Inclusion, Connections, Quality, Growth, and Financial improvements.

There is an item missing in the 2019 status which should be included in the Annual Report: **CDC** is hosting two hearing related opportunities: Hearing Loss Association of America's - Work Adults Chapter (HLAA), and the nation's first Toastmasters Club for people who have hearing loss: Audible Talker's Toastmasters.

**2020 Goals**. A list showing "Suggested CDC Goals Related to City Council Strategic Priorities" was provided for discussion. The goals relate to each of the five City Council's established strategic priorities and are broader than those from 2019. Commissioners chose all 14 goals to be included in the Annual Report.

Refinements will be detailed in future meetings.
