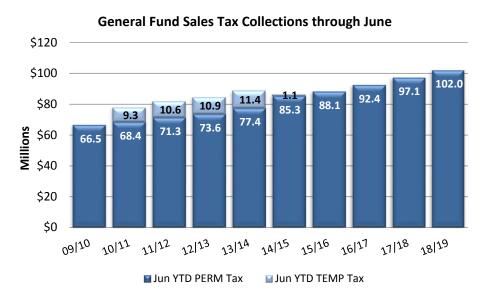

Subject: Tax Revenue Statistical Report – June 2019

Attached is the Executive Summary of the Tax Revenue Statistical Report for June 2019 covering May sales activity reported to the Arizona Department of Revenue (ADOR). The lag in reporting is due to the delay in receiving information from ADOR and processing.

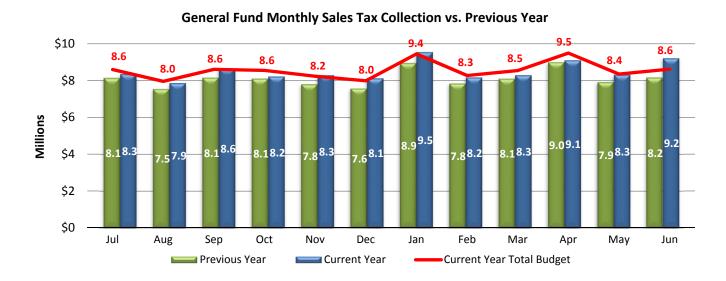
Total taxable sales increased by 6.5% over the same year-to-date period in the prior fiscal year.

Total sales tax revenue is also up 5.4% (\$8.5 million), as a result of strong retail (\$2.2 million), rentals (\$4.1 million), and combined bed tax and hotel/motel (\$1.0 million) activity. The graph to the right depicts year-to-date General Fund historical sales tax revenue from FY 2009/10 through FY 2018/19. General Fund sales tax revenue is up 5.0% (\$4.8 million) over the prior year-to-date period.



The graph below represents twelve months of activity, comparing current year General Fund monthly sales tax collections to the previous year.

Although sales tax is not budgeted on a monthly basis, the graph below applies historical collection percentages to the annual budget to gain insight into sales tax performance. Using this approach, sales tax collections in the General Fund are \$696 thousand below budgeted projections year to date. For the fiscal year ending 6/30/19, the actual variance to budget was -0.7% which is within the target of a +/- 3% variance (Performance Measure 5.10).
