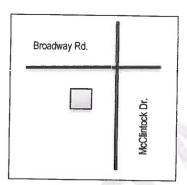
Agenda Item: 2

ACTION: Request approval to abate public nuisance items at the Swift Property located at 1530 E. Palmdale Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$2387.00 for abatement request: removal of dead tree in back yard.

RECOMMENDATION: Staff – Approval of abatement

<u>BACKGROUND INFORMATION</u>: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the SWIFT PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE194631: removal of dead tree in back yard.

COMMENTS:

Code Compliance is requesting approval to abate the Swift Property located at 1530 E. Palmdale Drive, in the R-2, Multi Family Residential district. This case was initiated 07/02/2019, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

07/02/2019 Complaint came into Neighborhood Enhancement (CE194631) for this property

regarding a partially dead Eucalyptus tree in the back yard of the property. Inspected the property and found the tree in the back yard to have dead portions. Mailed a notice

to the owner regarding the violation.

07/23/2019 The owner, Christopher Swift, called and asked about programs that could be of benefit

to him. He said he could not afford to take care of the tree right now. Some pamphlets

were dropped off at his house the following day.

08/16/2019 Called and left a message for Mr. Swift to get an update on the progress of the tree.

08/20/2019 Re-inspected the property and found the property to be in the same condition as before.

Mailed final notice.

08/23/2019 Returned a phone message to Mr. Swift. He had requested an extension until October

9th, 2019. The extension was granted.

10/17/2019 Issued a citation (#1701909) for the tree in the back yard, by this time, the tree was

completely dead. Pictures of the property were taken at this time as well.

11/21/2019 Mr. Swift had requested a court hearing. At that time, the judge found him responsible

for the violation.

12/05/2019 Received an abatement bid in the amount of \$2387.00 to have the tree removed.

RECOMMENDATIONS:

I am recommending the approval for the abatement at 1530 E. Palmdale Dr. The property is owned by Christopher Swift. The owner has been given ample time and opportunities to bring this property into compliance and has failed to take any corrective action. Several notices were mailed, and a citation was issued.

This office will submit this complaint to the Community Development Abatement Hearing Officer to be placed on the Hearing Officer agenda of **02/04/2020**. We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

Violation of City of Tempe Code 21-3-B-8

Any landscaping, visible from public property, that is substantially dead, damaged, or characterized by uncontrolled growth, or presents a deteriorated or slum-like appearance; uncultivated plants, weeds, tall grass, uncultivated shrubs or growth (whether growing or otherwise) higher than twelve (12) inches; or any dead trees, bushes, shrubs or portions thereof, including stumps; or any palm or similar type tree having dead or dry fronds descending downward from the base of the lowest living frond more than eight (8) feet or dry fronds longer than five (5) feet and closer than eight (8) feet to the ground.

1. CUT DOWN TO GROUND LEVEL OR REMOVE THE DEAD TREE FROM THE BACK YARD OF THE PROPERTY.

As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct the violation. If the violations have not been corrected within thirty days, our office will proceed with the abatement process.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$2387.00. In addition to the actual cost of abatement, an administrative charge of fifteen (15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate for judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.
