## Agenda Item 1 - Call to Order:

Christopher Watts, Library Advisory Board Chair, called the meeting to order at 6:02 p.m.

#### Agenda Item 2 - Call to the Audience:

  - Christopher Watts (C. Watts) explained that according to Arizona Open Meeting Law, the Library Advisory Board (Library Board) may only discuss, consider or make decisions on matters listed on the Library Board meeting agenda.
  - C. Watts further explained that each member of the audience is allowed three minutes for public comment.
- Rachael Brickner, Sr. Management Assistant City of Tempe Community Services Department, added that the members of the audience communicating intent to address the Library Board would be called to speak in the order in which they arrived and signed-in to the meeting.
  - Rachael Brickner (R. Brickner) reminded all that each member of the audience had three minutes to address the board, and explained that she'd be monitoring their time, and displaying visual signage (TIME) upon the expiration of their three-minute time segment.
  - R. Brickner further explained that she'd display a visual warning sign (30 SECONDS) when thirty seconds remained in each time segment specified for public comment.

 Stated that the Mesa Public Library does not allow parents to remain with their children in the Teen section (of the Mesa Public Library) and voiced displeasure with the content of material located within the Tempe Public Library.

## Agenda Item 4 - Friends of the Tempe Public Library Report:

- Kathy Husser (K. Husser), Deputy Community Services Director Library Services Division, explained that Larry Conway, President - Friends of the Tempe Public Library, and Jolene Gosling, Executive Director - Friends of the Tempe Public Library, were unable to attend the meeting.
- Per written communication from Larry Conway, K. Husser gave the following Friends of the Tempe Public Library (Friends of the Library) report:
  - Friends of the Library recorded 1050 hours for its 60+ volunteers in 2019, an increase of 200 additional hours from what was recorded in 2018.
  - Spring class registration for the Osher Lifelong Learning Institute opened on Monday, January 6, 2020.
    - Many classes have waitlists; after 24 hours of registration, 963 people registered for 30 classes.
- Friends of the Library honored its community partner, Changing Hands Bookstore, by catering a lunch for its employees on Monday, December 23, 2019.
  - Changing Hands has provided a steady-stream of high-quality used books to Friends of the Library for over a decade.
- As of current, Friends of the Library has contributed \$38,000 to various remodel phases of the Tempe Public Library.
  - Dedicated funds represent deposits and payments for demo work, design services, construction and the purchase and install of furniture.

## Agenda Item 5 - Staff Report:

Kathy Husser (K. Husser) introduced Teri Metros (T. Metros); K. Husser further explained that T. Metros was recently appointed to serve the remainder of the Library Advisory Board (Library

Board) term vacated by Joaquin Rios in December 2019.

- T. Metros stated that she was thrilled to be appointed to the Library Board, and that she looks forward to supporting the efforts of Tempe Public Library, Friends of the Tempe Public Library and the Library Board.
- Christopher Watts, Library Advisory Board Chair, welcomed T. Metros to the Library Board, and thanked her for her service.
- K. Husser reported that the Tempe Public Library (Library) staff team recently developed a Tempe Public Library Culture Code (Culture Code).
  - K. Husser affirmed that the Culture Code was developed by the entire Library team and speaks to the identity of the Library, Library operations and the 'why' behind the work and service delivery performed each day.
  - K. Husser added that the Culture Code helps to memorialize the positive culture at the Library and continues to progress and evolve into a community resource for Tempe that is caring, relevant and creates an atmosphere of learning for all.
  - K. Husser further explained that the Library will distribute a survey online and in-person (paper) to obtain resident and customer feedback regarding Library resources, community needs and priorities of Tempe Public Library moving into the new decade.
    - K. Husser stated that the Library survey will provide data that will be applied to the creation and implementation of a five-year strategic plan; the Library staff team will hone-in on results and synthesize data during its upcoming Staff Day.
    - K. Husser confirmed that a link to the survey will be available at tempe.gov/library;
       there will be a five-week window in which to collect responses. Surveys will be distributed at two Library outreach events; Tempe Fan Con, and at Tempe Play Day.
- K. Husser reported that she contacted Lori DeLuca, Tempe Resident, via telephone call and voicemail message regarding her public comments to the Library Board at the Library Advisory Board meeting on December 4, 2019.
  - Within the voicemail message, K. Husser directed Ms. DeLuca to a link on the Tempe Public Library website to gain access to the Library's Request for Reconsideration of Library Resources (Reconsideration of Resources), located under the Library Policies tab.
  - K. Husser confirmed that one Reconsideration of Resources was received on December 18, 2019.
    - Upon review and consideration of the request, a written response was sent to Ms.
       DeLuca on December 24, 2019, regarding the book, <u>Beyond Magenta: Transgender</u>
       Teens Speak <u>Out</u>, by Susan Kuklin.
- K. Husser announced that an Adult Services Librarian position open recruitment is ongoing; K.
  Husser explained that the vacancy occurred as a result of an internal lateral transfer into the
  Youth Services area.
  - K. Husser further announced that there will be an additional opening within the Youth Services area; Angela Weisner, Librarian, recently accepted her dream job as a Library

Branch Manager in Hawaii. Angela's last day is January 24, 2020.

- K. Husser advised the Library Advisory Board members to save the date of April 14, 2020; the Library will play host to its Volunteer Recognition Luncheon that day within the newly-remodeled Youth Services space.
  - Tween space furniture has been ordered via DEMCO, and the new Public Service Desk was installed on December 23, 2019.
  - The transition of youth book shelves will occur in late January/early February 2020 to accommodate a larger field of view of the nonfiction and DVD areas; the Puppet Theater and Story Time Room are still under design.
- K. Husser reminded the Library Board members that the Library is closed on January 20, 2020, in observance of the Martin Luther King Jr. Remembrance Day.

- Kathy Husser (K. Husser) thanked the Library Advisory Board (Library Board) members for attending the meeting.
- K. Husser inquired about future agenda items.
