Peggy would like the Commission to focus its scope of work on "social issue" months/topics related to domestic violence, dating violence, sexual assault, stalking, and sex trafficking

<u>Agenda Item 6 – Human Sex-Trafficking Conference Update and Discussion – Commission Member Kristen</u> Scharlau

Commission Member Kristen Scharlau recently attended the University of Toledo's International <u>Human Trafficking & Social Justice Conference</u>. This conference brings together researchers, practitioners, and individuals with lived experience in an effort to lay the groundwork for future collaborative research, advocacy, and program development. Agenda Item 8 – 2019 Board and Commission Annual Report – 2020 Goals

The following goals were identified for 2020:

- Safe & Secure Communities:
 - 1.05: Achieve ratings of "Very Satisfied" or "Satisfied" with the "Feeling of Safety in the City" greater than or equal to the top 10% of the national benchmark cities as measured in the Community Survey.
 - 1.06: Achieve response ratings of "No" relating to crimes not reported to police higher than or equal to the National Crime Victimization Survey benchmarks as measured by the Community Survey.
 - 1.12: Achieve a clearance rate of violent cases greater than or equal to the national 5-year average for cities our population size.
 - 1.30: Achieve a 50% service rate for victims of crime and persons experiencing crisis as measured by the Care 7 Trauma Support Service Assessment
- Quality of Life:
 - 3.10: Ensure that agencies who receive human service grants from the City achieve their performance goals related to homeless, youth, domestic violence, working poor, seniors, and individuals with disabilities
 - Create a quarterly report to Mayor and Council surrounding topics related to: domestic violence, dating violence, sexual assault, stalking, and sex trafficking.
 - Support CARE7's awareness campaigns surrounding Domestic Violence Awareness month, Teen Dating Violence Awareness month, Stalking/Human Sex-Trafficking Awareness month, and Sexual Assault Awareness month.
 - Continue to encourage City Council action on the Family Justice Center.
 - Outline specific needs of the proposed Family Justice Center
 - Conduct research project to include statistics identifying the need for a center in Tempe

Agenda Item 9 – Talking Points Update – Commission Member Kristen Scharlau and Jeffery Glover

At the September meeting, Kristen and Jeffery agreed to identify talking points for the Commission to use while conducting public outreach on domestic violence, dating violence, sexual assault, stalking, and sex trafficking. Jeffery recently met with sex-crime detectives and discussed trends they are seeing with internet dating and "sexting". Kristen would like to focus education/outreach on early intervention with teens. Jeffery and Kristen will send bullet points to Paul Bentley and Melissa Placencia.


