2. Request abatement of public nuisance items at the CLEVELAND PROPERTY located at 1808 E. Concorda Drive. The applicant is the City of Tempe (CE196974).

Michael Glab, Code Inspector, gave the following overview of this case:

- In October 2019, violations were observed, and first notice was sent to property owner.
- In November 2019, violations remained, and second notice was sent to owner.
- In January 2020, violations remained, and notice was posted to structure.
- Inspector Glab had communication with son-in-law of property owner and was told the inoperable and unregistered vehicles would be remedied.

- Inspector Glab noted that the vehicles are now operable, but not registered.
- Inspector Glab that this property is a repeat offender for unregistered vehicles on the property.

Hearing Officer MacDonald approved the 180-day abatement.

- 3. Request abatement of public nuisance items at the PAPE PROPERTY located at 1875 E. Palmcroft Drive. The applicant is the City of Tempe (CE194762).
  - Michael Glab, Code Inspector, gave the following overview of this case:
  - In October 2019, Inspector Glab responded to a complaint for unregistered vehicles in the driveway and mailed a notice to property owner.
  - In November 2019, Glab observed no change and mailed a second violation notice to property owner.
  - In December 2019, no progress was made, and a notice was posted to the structure.
  - Son of the property owner and Inspector Glab had a conversation, where son did not have any interest in bringing property up to code.
  - A temporary permit was issued, but it was already expired at the time of inspection.

Hearing Officer MacDonald approved the 180-day abatement.
