
Subject: Tax Revenue Statistical Report – April 2020

Attached is the Executive Summary of the Tax Revenue Statistical Report for April 2020 covering March sales activity reported to the Arizona Department of Revenue (ADOR). The lag in reporting is due to the delay in receiving information from ADOR.

Total year-to-date taxable sales increased by 5.5% (down from 6.8% last month) over the same year-to-date period in the prior fiscal year. Total sales tax revenue is also up 5.3% or \$7.3 million (down from 7.0% and \$8.6 million last month), as a result of growth in retail (\$4.8 million), contracting (\$1.8 million), and rentals (\$1.5 million) activity. The graph to the right depicts year-to-date General Fund historical sales tax revenue from FY 2010/11 through FY 2019/20. General Fund sales tax revenue is up 6.1% or \$5.2 million (down from 6.9% and \$5.3 million last month) over the prior year-to-date period.


The graph below represents twelve months of activity, comparing current year General Fund monthly sales tax collections to the previous year.

#### **General Fund Sales Tax Collections through April**



Although sales tax is not budgeted on a monthly basis, the graph below applies historical collection percentages to the annual budget to gain insight into sales tax performance. Using this approach, sales tax collections in the General Fund are \$2.1 million (up from \$2.0 million last month) above budgeted projections year to date.
