Agenda Item 4 - Presentation: Streetcar update

- Josh Roffler, Sr. Curator at Tempe History Museum, and Amanda Nelson, Transportation Public Information Officer, gave an update on the progress of Tempe Streetcar. Details include:
 - o 14 stops along the route will include public art and history panels depicting images of the area.
 - o Final funding from the Federal Transit Administration has been received.
 - Majority of the trackwork on Mill Avenue has been completed over the summer while students were out of school.
 - Transportation is collaborating with the Tempe History Museum to develop the content, look, and feel of the history panels. Historic Preservation staff and commission, community stake holders, and members of the tribal community have all been involved.
 - Goals for the panels:
 - Images are tied to the location of each station
 - Showcase the Tempe History Museum archives
 - Create a visual display with little text
 - Include a diversity of people, perspectives, and time periods
 - Have fun!

Agenda Item 5 - Presentation: IDEA Campus Update

- Donna Kennedy, Economic Development Director, and Maria Laughner, Economic Development Program Manager gave an update on the progress of IDEA Campus. Details include:
 - o Innovation, Discovery, Education and Art (IDEA) Campus
 - o Full development completion is believed to be within 10-15 years.
 - All tenants must be technology or biology related, combined with the arts.
 - O There will be a series of open spaces along the pathway for public use and to host activities such as art shows, markets, weddings, and other events.
 - Working with a hotel group developer for a high-end boutique location.
 - Eileen has been working with the hotel to brainstorm ideas on how to incorporate art features and create synergy between the new development and the TCA.
 - Amenities may include a rooftop penthouse restaurant, a high-end restaurant, and possibly a rooftop bar.
 - The buildings in the development will not all look alike. Each tenant will have the ability to customize their building design.
 - This major employment area will bring more patrons to the TCA.
 - Parking agreements are being completed for patrons and employees of the City of Tempe.
 - Boyer is working with Matt Warren and Jay Atherton on public art designs.
- Keith Burke, Community Services Director, explained that the plan to attach another city building (TCA annex) to the garage as a space for classrooms and studios was too costly to move forward with. The City is focusing budget on repairing and updating current facilities before construction of new ones.
- Commissioners expressed their dismay that the public is losing a much-needed amenity with the
 cancelation of the Arts & Culture Annex that would have been attached to the new parking garage. Arts
 & Culture programs are well attended by the community, and the current condition and size of Edna
 Vihel Arts Center is poor and insufficient.
- Commissioners expressed their concern that the arts component of IDEA campus has been diminished with the absence of the TCA annex addition.

• Parking will be open January 15th. The garage will initially have 820 spaces. Night and weekend parking will be at a reduced rate for patrons. A temporary lot will remain available until the second garage is constructed in the future.
