

**ACTION:** Request approval to abate public nuisance items at the 325 SHD Property located at 325 S. Hardy Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$830.00 for abatement request: Vacant lot landscape cleanup.

**RECOMMENDATION:** Staff – Approval of 180 day open abatement

**BACKGROUND INFORMATION:** City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the 325 SHD PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CM200330: Vacant lot landscape cleanup.

#### **COMMENTS:**

Code Compliance is requesting approval to abate the 325 SHD Property located at 325 S. Hardy Drive, in the R-3, Multi Family Residential Ltd. district. This case was initiated 02/20/20, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180 day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

#### **FINDINGS:**

2/20/2020 The Code Compliance Division received a for deteriorated landscape. Inspected property and found over height grass and weeds on a vacant lot. Notice to comply mailed to owner.

3/19/2020 Mailed final notice to comply to owner.

4/7/2020 received returned mail for owner. Mailed updated final notice to comply to owner at new address.

4/28/2020 Issued civil citation.

5/13/2020 Owner failed to appear for court.

5/22/2020 Notice of intent to abate mailed to property owner.

#### RECOMMENDATIONS:

I recommend an abatement of the nuisance violations at the property at 325 S Hardy Dr due to property owner's failure to bring property into compliance with Tempe City Code 21-3.B.8. The property owner has been given ample time to come into compliance and maintain the property. The property owner has been issued a civil citation and has failed to appear to court. There has been no indication that the property owner will bring the property into compliance. The property represents a health hazard and an eyesore to the community.

Without the intervention of abatement the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order.


#### 1. REMOVE GRASS AND WEEDS FROM VACANT LOT.


As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct the violation. If the violations have not been corrected within thirty days, our office will proceed with the abatement process.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$830.00. In addition to the actual cost of abatement, an administrative charge of fifteen (15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate for judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.
