Subject: Tempe Family Justice Commission Communication

Purpose

This memorandum is to inform Mayor and Council of the Tempe Family Justice Commission's (FJC) future communication plan. Specifically, the Family Justice Commission will be sending Friday Packet updates throughout the year to:

Provide education and advisement on family justice topics based on literature, best practices, and subject matter expertise.

Invite Mayor and Council to join FJC commissioners at events, seminars, trainings, etc. related to family justice topics.

Seek Mayor and Council's support through proclamations that address topics such as Sexual Assault Awareness, Domestic Violence, and Human Sex Trafficking months.

Context

As written in the City of Tempe's ordinance Section 2-387, The FJC's powers and duties include:

- To advise the City Council and assist city departments in promoting access to justice and safety for victims of domestic violence, dating violence, sexual assault, stalking, and sex trafficking;
- To advise the City Council and assist city departments in providing leadership and facilitating access to resources that will contribute to wrap-around services and a multi-disciplinary response for the victims and survivors;
- To advise the City Council and assist city departments on coordinating cross training and multi-disciplinary tools to provide training opportunities to criminal justice personnel and healthcare providers about educational initiatives and systems based standards of practice that are critical to serving the victims of domestic and sexual violence and keeping them safe.
- To advise the City Council and assist city departments on expanding education and outreach to vulnerable populations.

As reported in the FJC's 2019 Annual Report, the FJC is committed to creating and submitting periodical reports to Mayor and Council on topics related to: domestic violence, dating violence, sexual assault, stalking, and sex trafficking. These periodicals will provide education, recommendations, and advisement; invite Mayor and Council to join FJC commissioners to

attend events, training, seminars, etc.; and seek Mayor and Council support through formal proclamation.

This new initiative supports City Council Priorities: Safe and Secure Communities (performance measures 1.05, 1.06, 1.12, 1.30) and Quality of Life (performance measure 3.10).

You will receive the first periodical in April 2020. This periodical's focus is sexual assault in alignment with April's national campaign to raise sexual assault awareness. As you receive this periodical, or future periodicals, we welcome you to join us in this dialogue and seek your support in promoting these incredibly difficult social issues toward positive change.

We are pleased to add this new method of communication in alignment with our purpose to serve you.
