Commission Member Mary O'Grady met with the City of Tempe Mayor and Tempe City Councilmembers Doreen Garlid and Lauren Kuby in late July regarding the Family Advocacy Center. Mary mentioned these Councilmembers are supportive and ready to move forward with the Family Advocacy Center.

Agenda Item 7 – Initial Discussion on Potential Donor Opportunities in Support of a Family Advocacy Center

Commission Member Kristen Scharlau confirmed the support from Tempe Police Department for the Family Advocacy Center. The Director of the City of Maricopa's Advocacy Center shared with Kristen the start-up costs and monthly budget for their center. The Commission discussed potential funding sources to support the Family advocacy center. One potential sustainable funding source is the Victim of Crimes Act (VOCA) grant process. The Tribal Gaming Grants and the Tempe Diablos might be an option for startup costs. Peggy mentioned the McCain Center and the Tim Tebow Foundation as a couple non-profit organizations that the Commission could potentially reach out to. Mary also mentioned the Hickey Family Foundation.

Deputy Human Services Director, Paul Bentley commended the progress and efforts of the Family Justice Commission on the Family Advocacy Center.

 - Created a process to continue submitting periodical reports
- Support CARE7's awareness campaigns surrounding Domestic Violence Awareness month, Teen Dating Violence Awareness month, Stalking/Human Sex-Trafficking Awareness month, and Sexual Assault Awareness month.
- Continued to encourage City Council action on the Advocacy Center and collaborating with Council to make the center a reality
- Tempe Police Department and Human Services CARE7 continued to provide statistical updates on victimization within the City of Tempe.

- Continue to update data research to include statistics identifying the need for a center in Tempe
- Collaborate with its elected officials, City staff, Commission members and other appropriate persons to bring focus, research and expertise to the City Council to establish an Advocacy Center.
- Continue to provide periodical reports to the city regarding crimes involving children (including child abuse), domestic violence, sexual assault, and sex trafficking.
