#### **USCM Federal Updates**

#### EPA's Affordability Guidance

The Conference of Mayors' Water Council has worked with EPA on the issues of affordability and unfunded Clean Water mandates for the past decade. We were successful in passing legislation that created Integrated Planning and required EPA to rewrite their Affordability Guidance which they recently unveiled and can be found <a href="https://example.com/here">here</a>.

Our USCM Staff is doing a detailed analysis of the draft guidance, but generally-speaking, it looks like EPA included many of our recommendations. Some of the highlights of the guidance include:

EPA is moving away from basing their mandate costs from the city's median income measure to one that will consider the impact on the lowest 20% of household income, as well as a poverty impact. This alone will moderate the financial burden by extending the schedule to comply with the mandate;

EPA is also proposing to schedule compliance using a model to identify financial impacts using finance rates and debt amortization periods in order to phase out debt and extend the compliance schedule to avoid or reduce expensive refinancing;

The proposed Guidance has a level of flexibility and transparency that allows cities to make their best case for choosing solutions.

It is important to note that EPA is not reducing or eliminating the requirement for cities to delay implementation of our Clean Water obligations.

Speaker Pelosi Releases New HEROES Bill – New Effort to Restart Negotiations on COVID-19 Relief Last night, House Speaker Nancy Pelosi and House leaders released a revised HEROES bill as a proffer to restart the negotiations on emergency fiscal assistance before Congress goes home for the reelection campaign

The total amounts contained in the revised HEROES Act would be \$436 billion for state and local governments. Contained therein is \$179 billion for local governments with a split down the middle between our cities and counties, providing approximately \$90 billion for each. Retained in this new House proposal is the CDBG-type structure modified to make sure entitlement cities, 50,000 and above in population and non-entitlement cities, those below 50,000, hence all cities – large, medium, and small – would receive direct funds from this legislation.

The bottom line here is that the smaller cities get direct money without having to deal with their state legislators or governors. This is most important because not one red cent of direct COVID-19 assistance has come from Washington, except to the 38 cities over 500,000 who received the money in the CARES Act earlier this year.

Secretary Ross Tweets Surprise October 5th Deadline for Census, Federal Judge Had Blocked Moved Last Week

A surprise tweet came last night from Commerce Secretary Wilbur Ross announcing a "target date" of October 5 to finish the 2020 Census count.

The tweet last night came after a federal judge blocked the Trump Administration from ending the count this week. District Court Judge Lucy Koh blocked the Census Bureau from ending the census count on the earlier date of September 30, ruling in agreement with plaintiffs, the National Urban League, and

other advocates including the United States Conference of Mayors, that the shorter period of time would harm communities due to the age-old problem of a Census undercount.

All parties are scheduled to go back into court as the saga of the timing of the 2020 Census count continues, which has been seriously challenged by civil unrest, COVID-19, and economic downturns in many highly populated areas of the United States of America.

Secretary Ross' nighttime tweet has affected commentators and organizations involved throughout the nation. Let's hope the courts can resolve the matter soon so we can continue with our census counts in all cities to make sure the best, most accurate count is made in this challenging year of 2020.

### House Moves Forward With Bill As Negotiations Do Not Produce A Deal Today

House Speaker Nancy Pelosi (D-Calif.) met with Treasury Secretary Steven Mnuchin for over 90 minutes today in her Capitol office. The two discussed the substance of a <u>new proposed COVID-19 relief package</u> that the Democrats unveiled earlier this week.

The package, which at a \$2.2 trillion is a scaled-down version of the HEROES Act, incorporates the spending priorities of the original HEROES Act at about one-half the original appropriation proposal amounts. The bill includes \$89.5 billion to municipalities using the modified CDBG allocation method that NLC proposed, as well as some technical improvements to the CARES Act, namely, expanding CARES fund eligibility to cover lost revenues and extending the expenditure deadline through the end of FY2021. A summary of the state and local section of the bill may be found here.

At the beginning of the meeting, Mnuchin was expected to counter the Speaker's \$2.2 trillion offer with \$1.5 trillion, a figure more in line with the Problem Solvers Caucus, and one that Pelosi had previously dismissed.

White House Chief of Staff Mark Meadows stayed in the Speaker's Office with Mnuchin for only approximately 40 minutes. Mnuchin and Pelosi struck multiple spending deals in the spring, and some speculate that the former Freedom Caucus leader Meadows is the hold up in the negotiations.

After meeting with the Speaker, the Secretary shuttled across the Capitol to meet with Senate Majority Leader Mitch McConnell (R-Ky.), and Pelosi issued the following statement:

"Today, Secretary Mnuchin and I had an extensive conversation and we found areas where we are seeking further clarification. Our conversation will continue. We will be proceeding with our vote tonight on the updated Heroes Act in order to formalize our proffer to Republicans in the negotiations to address the health and economic catastrophe in our country."

The House ending up holding off on the stimulus vote tonight giving the negotiations more time. Never a dull moment, but a positive sign nonetheless.

#### **NLC joins COVID RELIEF NOW Coalition**

Today, the National League of Cities, American Hotel and Lodging Association, International Franchise Association, the U.S. Travel Association, and the National Association of Counties held a press conference today to launch the COVID Relief Now Coalition – a collaboration of more than 150 trade groups representing the public and private sectors calling on Congress and the Administration to vote on a COVID relief package before any recess period over the election.

NLC executive director Clarence Anthony was joined by Savannah Georgia Mayor Van Johnson who underscored the significant strain that local municipalities are under without any support from the federal government. Mayor Johnson said, "We have to stay until the work is done. We have to stay until the work is completed, so I say to Congress: No relief, no recess."

Across the spectrum of airports, hotels, small business owners and local government, it is clear that Congress must prioritize a relief package to ensure economic relief. This broad coalition stands united to pressure Congress to make a deal before the consequences become even more dire. Below you will find the clips from today's release. Politico Influence: Trade Groups Try To Pressure Lawmakers To Make A Deal

TRADE GROUPS GIVE IT ONE MORE SHOT: An ad hoc coalition of more than 150 trade groups representing industries hurt by the pandemic is trying to pressure Congress and the Trump administration to strike a last-minute deal before leaving town. The message: Lawmakers shouldn't go home until they pass another coronavirus relief bill. The strategy: Shame. "The idea that Congress would leave town without some kind of relief package is shameful," Chip Rogers, the president and chief executive of the American Hotel & Lodging Association, told reporters this morning. The newly organized COVID RELIEF NOW coalition sent a letter to Senate Majority Leader Mitch McConnell, Senate Minority Leader Chuck Schumer, House Speaker Nancy Pelosi and House Minority Leader Kevin McCarthy today as Treasury Secretary Steven Mnuchin heads to Capitol Hill and House Democrats push to vote on their bill as soon as this afternoon. "We are writing to implore you to reach a bipartisan deal on legislation to prevent catastrophic economic harm that would result if Congress does not pass additional emergency relief before adjourning for the election," the letter reads. Among the groups that signed onto the letter: Airlines for America, the American Gaming Association, the American Hotel & Lodging Association, the International Council of Shopping Centers, the National Association of Counties, the National Association of Theatre Owners, the National Governors Association, the National Independent Venue Association, the National League of Cities, the National Restaurant Association and the U.S. Travel Association.

## The Hill: Over 175 Public And Private Sector Groups Ban Together To Call For No Recess Without Relief

A coalition of travel, hotel, franchise, and state and local government groups called for Congress to not go on recess without providing relief for sectors devastated by the coronavirus pandemic. More than 175 organizations representing the public and private sector, including the American Hotel & Lodging Association (AHLA), International Franchise Association (IFA), National Association of Counties, National League of Cities, Airlines for America and the US Travel Association, wrote a letter to congressional leadership on Wednesday. "The public servants in Washington, D.C. are very focused on protecting their own jobs through the election but right now don't really seem to care about protecting the jobs of the people they represent," Chip Rogers, AHLA CEO, said on a call with reporters on Wednesday.

### Roll Call: House Scraps Vote On Partisan Virus Aid Bill Amid Last-Ditch Talks

Pressure for a deal increased Wednesday as organizations representing travel and hospitality businesses as well as local governments blasted lawmakers for not making enough progress. They urged lawmakers on a press call to stay in session until an agreement is reached. One of the chief targets was the Main Street Lending Program, a Federal Reserve initiative created to provide \$600 billion in financing for small and medium-sized businesses. Congress appropriated funds in March for the Treasury Department to provide a backstop in case of defaults across various Fed facilities; up to \$75 billion is set aside for the Main Street program. But Treasury has only invested half of that so far and the Fed as of Aug. 31 had backed about \$1.1 billion worth of loans. "There is no other way to look at the Main Street Lending [Program] than to say so far it has been a miserable failure," said Chip Rogers, president and CEO of the American Hotel & Lodging Association. Rogers said "only a little over a billion has been lent out, and if that is not the definition of a failed program I am not sure what is." The groups also called for redirecting \$146 billion left in Paycheck Protection Program coffers to a second round of forgivable loans for small businesses with steep losses. Franchises such as gyms, dry cleaners and restaurants, which employed 8 million workers, experienced 32,000 closures during the pandemic, Robert Cresanti, president and CEO of the International Franchise Association, said. He said almost 11,000 of the closings are permanent. Without congressional aid, he said, another 36,000 businesses may not survive the winter.

### Travel Weekly: 'No Relief, No Recess': Coalition Demands That Congress Pass A Stimulus Bill

A coalition of nearly 200 travel-focused companies, associations and municipalities joined forces to demand that Congress take action before the election and agree on a stimulus package to bring relief to the millions of travel employees and businesses suffering due to the coronavirus pandemic. The group, called Covid Relief Now, sent a letter to Congress on Wednesday, saying legislation would "prevent catastrophic economic harm that would result if Congress does not pass additional emergency relief before adjourning for the election." Congress has not agreed on additional relief since the Cares Act was introduced in March. Earlier this summer, the House passed a \$3 trillion relief package, and the Senate responded with its own \$300 billion package. Neither bill passed, leaving relief in a stalemate. With the slogan "No Recess Without Relief," the coalition warned that without action, millions of people will be furloughed or terminated and millions of unemployed will lose their unemployment insurance pandemic benefits; hundreds of thousands of companies are at risk of shutting down permanently, it said. During a conference call on Wednesday, Chip Rogers, CEO of the American Hotel & Lodging Association, said the message to Congress "is simple: Do not leave without finishing your job."

### Hotel Management: AHLA Repeats Call For Bipartisan Support Of PPP Expansion

A day after House Democrats released a \$2.2 trillion aid package that would authorize more funds for a second round of Paycheck Protection Program loans, the American Hotel & Lodging Association and several travel-related organizations renewed calls for further congressional support to the sector, bringing in both state tourism representatives and business owners from each state to put a human face on the crisis. During a press briefing, AHLA President and CEO Chip Rogers acknowledged the PPP has been "very valuable to our industry and many small businesses around the country," but emphasized that the measures were only meant to last for 10 weeks. With the summer travel season already over, he said, travel-related businesses need another round of support. "Our industry looks at declining revenues and dramatically increasing expenses at a very very difficult time."

# Travel Pulse: New Coalition Of Tourism Organizations And Governments Calls On Congress For Immediate Relief

A COVID Relief Now Coalition has been launched with organizations in the private and public sectors calling on Congress and the Administration to provide relief to businesses and governments before

elected officials go on recess in preparation for the upcoming election. Led by the American Hotel & Lodging Association (AH&LA), the coalition held a press conference to warn Congress that if it fails to act, millions of employees will be furloughed or terminated; millions of unemployed Americans will lose their unemployment insurance pandemic benefits; hundreds of thousands of companies will be at risk of closing their doors forever, and the vast majority of state and local governments will have to curtail critical services in order to balance budgets due to a decline in tax revenue. Chip Rogers, CEO of AH&LA, said that 150 organizations had originally signed up for the coalition in the 24 hours before the press conference while another 25 joined during the first half-hour of the press conference.

### Lodging Magazine: AHLA Joins New Coalition Calling On Congress To Pass COVID Relief Now

COVID RELIEF NOW, a new coalition of nearly 200 major public and private sector groups across the United States, today called for "No Recess without Relief," imploring Congress to not leave town for the 2020 elections without passing additional COVID economic relief. In a letter sent to Congressional leaders, the COVID RELIEF NOW coalition wrote that if Congress fails to act, millions of employees will be furloughed or terminated; millions of unemployed Americans will lose their unemployment insurance pandemic benefits; hundreds of thousands of companies will be at risk of closing their doors forever; and the vast majority of state and local governments will have to curtail critical services to balance budgets due to a decline in tax revenue. ### Bus Ride: Public And Private Sector Leaders Call Congress To Act On COVID Relief

COVID RELIEF NOW, a new coalition of nearly 200 major public and private sector groups across the U.S., today called for "No Recess without Relief" imploring Congress to not leave town for the 2020 elections without passing additional COVID economic relief – stating millions of jobs and survival of small businesses as well as vital government services are on the line. The coalition stated that if Congress fails to act, millions of employees will be furloughed or terminated; millions of unemployed Americans will lose their unemployment insurance pandemic benefits; hundreds of thousands of companies will be at risk of closing their doors forever; and the vast majority of state and local governments will have to curtail critical services in order to balance budgets due to a decline in tax revenue. "It is imperative that Congress provide aid to those industries that are in the most need, including the motorcoach industry, in the next relief bill they pass," said American Bus Association president and CEO Peter Pantuso. "Like many industries, the bus industry is on the verge of collapse with most of our 3,000 small, family owned businesses at risk of closing forever. We have seen our nearly 100,000 industry jobs lost since March. Bus drivers, administrative personnel, mechanics, tour directors, accountants and all the other highly skilled workers that help this industry provide safe and reliant transportation want to come back to work, they want to make a living again. The only way we bring workers back is through a lifeline from Congress to help our businesses stay open."

Chicago Tribune: <u>Hotel Job Losses In Illinois Could Double Without Additional Federal Aid, Industry Group Warns.</u> 'We Need Congress To Act And Act Now.'

Hotel job losses in Illinois could double if Congress doesn't pass another coronavirus stimulus bill, according to an industry group report. The state has already lost more than 67,000 hotel-related jobs since March and about half of Illinois hotel owners surveyed say their properties are in danger of foreclosure, according to an American Hotel and Lodging Association survey conducted in mid-September. The survey polled about 1,000 association members nationwide, according to Chip Rogers,

the group's president and CEO. At the start of the pandemic, hotels across the Chicago area furloughed and laid off workers, under the strain of stay-at-home orders and suspended travel. The hotel industry, which is a large source of jobs and tax revenue for the state, has been one of the sectors hardest hit by the health crisis. In September, leisure and hospitality jobs in Chicago were down almost 27% from 2019, according to the Bureau of Labor Statistics. "In Illinois, winter is coming both literally and figuratively. We need Congress to act and act now," said Michael Jacobson, president and CEO of the Illinois Hotel & Lodging Association, during a news conference Tuesday.

### Florida Politics: Business, Government Coalition Demands COVID-19 Relief Before Election Day

A national effort including Florida business and government advocates wanted COVID-19 relief passed before Election Day. COVID Relief Now, a coalition of more than 200 organizations, called on Congress to remain in Session until the House and Senate agree on a legislative package. "We are writing to implore you to reach a bipartisan deal on legislation to prevent catastrophic economic harm that would result if Congress does not pass additional emergency relief before adjourning for the election," reads a letter from the group. The coalition includes such Florida lobbying voices as the Florida Restaurant & Lodging Association, Florida Retail Federation and the Florida West Coast chapter of Independent Electrical Contractors. They joined a number of national business groups like the National Small Business Association and National Restaurant Association. The coalition also includes government associations including the National Conference for State Legislatures, National Council of State Legislators, National Association of Counties and National Governors Association.

#### **Federal Funding Continued and Heroes Act**

Last night, the Senate passed a "Continuing Resolution" by a vote of 84-10 funding the federal government until December 11, 2020. This averts a government shutdown, and punts difficult FY 2021 funding decisions until after the November 3 election.

House Speaker Pelosi just said that a deal with the White House on the new Heroes Act—with the local government funding—does not seem likely. As a result, the House is expected to vote on the Heroes Act later today. They were holding off to see if a deal could be reached, but since it is increasingly unlikely, the Speaker wants to let the House vote on it. It will be a party-line vote, with nearly all Republicans voting against the bill. The Senate is not expected to consider the bill until after the election, if at all.

### Briefs Filed in Public Interest Lawsuit Challenging EPA Attainment Determination

The MAG special Washington, D.C. legal counsel has transmitted the Environmental Protection Agency's Response Brief, State of Arizona Amicus Brief, Arizona Chamber of Commerce and Industry Amicus Brief, and the Arizona Center for Law in the Public Interest Petitioner Reply to the Arizona Chamber of Commerce and Industry Amicus Motion. These briefs have been filed in the lawsuit initiated by the Arizona Center for Law in the Public Interest to review the Environmental Protection Agency's Determination of Attainment by the Attainment Date for the 2008 Ozone Standard for the Maricopa nonattainment area. Staff will continue to provide updates on this topic.

### Maricopa County Tempe August COVID-19 Data Report

Attached is the August Data Report created by Public Health for Tempe, provided in both English and Spanish. This document will be included on our website. You will notice a change in that the data on this document is now broken out week by week, rather than a 30 day period. However, the overall comparison/stop light is still where Tempe is relative to Maricopa County for the entire month.

Our apologies as these worksheets are a bit late this month. These reports have been prepared since September 15<sup>th</sup>, however as we were about to distribute them we were informed by ADHS that more than 700 COVID-19 laboratory results were delayed, many of which were from the month of August. Many were also lacking a physical address associated with the case, which makes it difficult to accurately geocode. Please be advised that we are still waiting on that data, and as a result are distributing these August reports as is, without its inclusion. This means that if address data is received and updated, the August reports may vary slightly upon final reconciliation.

As you know, Maricopa County recently participated in a new project in the community as part of the COVID-19 response. Known as a serosurvey, this effort invited residents of 29 pre-selected communities in Maricopa County to participate in a health survey and COVID-19 antibody test. By conducting this serosurvey with a representative sample of Maricopa County's population, public health professionals will be able to estimate the true spread of COVID-19 in our county. We are pleased to inform you that the survey has been completed with 169 households voluntarily participating. We will be sure to report out final results once they are available.






# Response Rate by Block Group

**SUBJECT:** Tempe Cooling Center Update



#### PURPOSE:

The purpose of this memo is to provide an update to Mayor and Council regarding the planned closure of the Tempe Cooling Center.

#### **BACKGROUND:**

As a result of COVID-19, many city facilities and local businesses closed in the spring. With Council's guidance, several city departments collaborated to identify a location, develop safety protocols, secure staffing and sanitizing services, and prepare multiple forms of communication for the public. The Tempe Cooling Center (Cooling Center) began operations on May 18 at the Cahill Senior Center. After one month of operations, the Cooling Center was relocated to a centralized location on the Tempe Community Center Complex; the Pyle Adult Recreation Center. The centralized location provided ease of access to visitors, as well as increased capacity capabilities. To date, the Cooling Center has been utilized over 2,200 times.

The success of the Tempe Cooling Center is a direct result of an enormous team effort from the Community Services and Human Services Departments, the Office of Strategic Management and Diversity, Tempe Fire Medical Rescue, Tempe Police Department, and the Office of Sustainability. The efforts of those involved created a lifesaving service for the most vulnerable in our community.

#### **COOLING CENTER CLOSURE:**

The Cooling Center Task Force has reviewed and discussed options for the closure of the Tempe Cooling Center. The Task Force is recommending that the Cooling Center end its operations on October 18, 2020. This decision was made through careful consideration of historical weather trends, scan of other local cooling center plans, and guidance provided by Paul Iniguez of the Regional National Weather Service.

Barring unforeseen significant weather changes (e.g. heat wave), or additional guidance, the Task Force has identified logistics for closing the Cooling Center including internal/external communication and final reports/press releases for this successful initiative. The Task Force will continue to meet through the closure to ensure a successful transition for staff and patrons.

Patrons will be notified, prior to the closing of the Cooling Center, of additional areas for heat relief.

# StoryWalk® and Storytime Live with Tempe Public Library


