It was determined that abstention was not required by either the Open Meeting Law or Robert's Rules of Order for not being present at the meeting. However, if Commissioners are uneasy or unsure of approving minutes at any time, they have the option to abstain. The minutes will be carried over to the December 2 meeting for approval.)

#### Item 3. Advancing Abilities and Inclusion Focus Group Feedback

The Advancing Abilities and Inclusion (AA&I) Focus Group originated from former Chair Wendy Dietrich's and the Commission's work with Councilmember Robin Arredondo Savage to brainstorm ways to advance inclusion of people with disabilities in Tempe.

The AA&I Focus Group was hosted by Council Member Robin Arredondo Savage and Strategic Management and Diversity Equity and Inclusion Manager Jonae Harrison. Vice-Mayor Lauren Kuby also was in attendance and provided closing remarks.

The purpose of the Focus Group was to kick off a "Listening Tour" to gather information first from city department directors and staff, on areas where Tempe could increase disability inclusion. Staff, Interns, and Commissioners were attendant as "Listeners."

The AA&I Focus group meeting was held on October 30 at the Tempe History Museum and consisted of about 60 attendees which included department directors and front-line staff. Information was solicited via a question and answer session. Information was shared regarding upcoming ADA and disability related training opportunities; Strategic Management Goal 3.13 on Disability Social Inclusion; the ADA Transition Plan and the ADA Story Map; Access Tempe – a database of disability organizations, disability employment supports through Tempe's Building Employment Supports and Training (BEST) efforts.

Three staff and an ASU Intern Jackson Doe, took notes, and each table was also provided a note pad to include any information they did not feel comfortable bringing up. Additional notes were taken on flip charts. The notes will be compiled and analyzed to determine areas to further research and address.

Three Commissioners attended: Chair Katherine Schmidt, Commissioners Rene Williams and Paul Kent.

#### Feedback:

**Commissioner Paul Kent**: We attended in "Listening Mode" and there were good comments from everyone. They brought up the need for information on visible and invisible disabilities and need for information on accommodations. They also commented on concerns and the needs of aging parents of adults with developmental disabilities, aging adults.

**Commissioner Rene Williams**: There was discussion about subtle disabilities, disabilities in communications, accommodations. They told their stories of situations they have experienced. They brought up Social Security and the need for housing supports.

**Next Steps:** The next steps will be to report to the Mayor and City Council on the information received and potential actions to recommend, after the feedback is recorded. Early next year, a public involvement plan, to hear suggestions and comments furthering the "Listening Tour," concept to the community, will be developed. Information will be solicited from disability advocacy groups and disability agencies to determine actions Tempe can take to advance abilities and inclusion of people with disabilities.

Tempe hosts the event which will have 40 employers, three sessions of class instruction on interview etiquette, mock interviews and a 30-second elevator speech opportunity. Chair Kathleen Schmidt, Commissioners Irene Mochel and Paul Kent volunteered to staff the CDC table.

#### Item 7. Tempe's BEST Update.

Tempe's Building Employment Supports and Training 4<sup>th</sup> quarter report was provided showing 91% of the tasks were completed for the year.

A second-year grant for \$124,731 was awarded by Arizona Developmental Disabilities Planning Council (ADDPC) to continue the pilot program. Tempe is will provide more than 100% match of \$152,731 in cash and in-kind supports, which includes wages for six part-time, temporary positions.
