#### 3. Presentation: The ARC of Tempe

CEO Colleen Tighe of the Tempe ARC presented information to inform the Commissioners on services provided and answer questions. ARC specializes in serving people with Intellectual and Developmental Disabilities (IDD) who are highly capable. They provide social services, recreation, Toastmasters and other programs.

#### A. What services can Tempe help you provide?

Tempe can help by providing more services to help the transitioning IDD population which is from 18 to 21. After 21 all assistance stops.

#### B. How can Tempe better help you?

Help reach the transitioning population and provide advocacy, recreation, socialization activities, and educate parents on services available to help with transition, i.e. promote availability of transition coaches,

Help build connections between people with IDD and the general population.

Help with disability resources, funding for IDD inclusion activities.

Provide a marketing program to train Tempe staff and the public about Disability Etiquette. When families with members who have IDD are in the public, the public doesn't always respond appropriately.

Provide an Autism 101 training on transitioning adults with a social work component to help families.

Promote the ARC Event Calendar

Provide events that are inclusive to help families with children and adults with IDD be seen in the public more. Advertise that the event is IDD / Disability inclusive.

#### C. What areas are you seeing in Tempe that need attention?

There is a tremendous problem with isolation and the suicide rate for this population is 15 percent more than for the general population and not much is shared about this. There are resources that can help.

There are foster homes with transitioning adults with IDD that are isolated. Promoting activities that bring together transition coaches and IDD populations in City opportunities can help.

#### 4. Debrief: 2019 Disability Awards

#### 6. Inclusive Recreation Progress - Update

Chair Wendy Dietrich reported that a supplemental funding request was submitted to City Council and it was well received. The funding is to provide additional staff to facilitate the proper staffing ratios required by law in serving children with disabilities in recreation settings.

An inclusion request form has been approved so the process and information required to provide accommodations is formalized.

#### 7. Discussion: Commission and Staff Announcements.

Connector Award. Chair Wendy Dietrich said that there is an exciting opportunity or funding coming out to address isolation called the Connector Award being offered by the Tempe Community Council. The purpose is to explore ways to eliminate isolation and provide incubation support to develop the idea. The award would be for up to \$50,000 and requires that there be at least two collaborators. Multiple awards are possible.

- May Meeting. Chair Wendy Dietrich said she will not be available for the May meeting and Vice Chair Katherine Schmidt will be serving as chair.
- Chair Resigning in July. Chair Wendy Dietrich also announced that she
  will be moving out of state soon and will be resigning effective July 2019.
  The June 3 meeting will be her last meeting. Vice Chair will serve until end
  of year.
- Presenter for next month. Commissioners requested a presenter regarding counseling for people with disabilities on how to consider employment when they are receiving federal disability benefits such as Social Security. Staff will reach out to Ability 360 which has a staff person who provides this counseling.
- **No July Meeting**. There will be no meeting in July for summer break.
- Abiity360 Health and Wellness Fair flyer is in the folder.
- Next CDC meeting is May 8.
