
Agenda Item: 2

ACTION: Request approval to abate public nuisance items at the Chapman Olisky Property located at 3230 S. Birchett Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$989.00 for abatement request: remove junk and miscellaneous household items from front & side yards.

RECOMMENDATION: Staff – Approval of 180 day open abatement

<u>BACKGROUND INFORMATION</u>: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the CHAPMAN OLISKY PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE197362: remove junk and miscellaneous household items from front & side yards.

COMMENTS:

Code Compliance is requesting approval to abate the Chapman Olisky Property located at 3230 S. Birchett Drive, in the R1-6, Single Family Residential district. This case was initiated 11/15/19, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180 day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

11/15/19 - Case was opened proactively for a dead citrus tree in the front yard. Notice to comply was mailed to the owners with a re-inspection date of 12/19/2019.

12/19/19 – The property was inspected and the dead tree was still there. In addition junk, furniture, miscellaneous household items and numerous boxes were observed in both side yards. First notice was re-sent with a re-inspection date of 1/21/20.

1/21/20 – The property was inspected and the dead tree was gone. All of the observed items were still stored in both side yards. As progress had been observed, first notice was sent again with a re-inspection date of 2/6/20.

2/6/20 – All of the previous areas filled with the observed items remained; in addition items were now stored in front of the garage area and on the front porch. Final notice was sent with a re-inspection date of 2/25/20.

2/20/20 – Spoke with owner Elizabeth Olisky who explained she functions as a donation point for a charity. I explained that this was a violation and she would have to come up with a different process. I asked Ms. Olisky to come up with a date that she would have her issues resolved and she agreed to let me know.

3/19/20 – The owner never contacted me. The piles of donated items had increased to include more items in front of the garage and a large shade canopy had been added to the north side yard that was completely full of stored items. I spoke with the owner and she explained that the pandemic shutdown made it impossible for her to arrange a pick-up for the items. She agreed to have the items removed by 6/1/20.

6/2/20 - The property was re-inspected and no improvement was observed. Final notice was re-sent.

6/24/20 - The property was re-inspected and no improvement was observed. I received an email from the owner claiming the entity that is supposed to pick up the items keeps pushing her out and was scheduled for July 23rd; I told her that I would re-inspect on July 27th and that she would need to make other arrangements if her scheduled pickup was delayed again. I told her this would be her last extension.

8/3/20 – The property was re-inspected and the canopy was gone but the stored items had been moved, distributed along the garage exterior and other walls. The items in the side yards, in front of the garage and on the front porch remained. Photos were taken and citation #1619549 was issued to Elizabeth Olisky on 8/4/20.

9/23/20 – The property was re-inspected and numerous items remain stored in all the previously mentioned areas. Code Compliance filed for an Abatement Hearing.

RECOMMENDATIONS:

I recommend the approval of a 180-day open abatement period for removal of junk, trash and debris from 3230 S. Birchett Drive, which is owned by Cory Chapman and Elizabeth Olisky. The owners have been given ample time and opportunities to bring the property into compliance and have failed to take corrective action.

This office will submit this complaint to the Community Development Abatement Hearing Officer to be placed on the Hearing Officer agenda of November 3, 2020, located at the Tempe Council Chambers, 31 E 5th Street, at 5pm. We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

CC 21-3.b.1

Filthy, littered, debris or trash-covered exterior areas

If the violations have not been corrected within thirty (30) days, our office will proceed with the abatement process. As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below:

CC 21-3.b.1

Please remove the bags, bins, boxes, furniture and miscellaneous household items stored in the driveway, garage area, front porch area, and both side yards of the property.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$ 989 . In addition to the actual cost of abatement, an administrative charge of fifteen(15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the City for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.

If the defendant fails to appear within the time specified, and either pay the fine for the violation or request a hearing, judgment by default will be entered in the amount of the fine designated on the citation for the violation charged plus a penalty amount.
