#### **National League of Cities, Virtual City Summit**

Next week is the City Summit of the National League of Cities (NLC). The City Summit is NLC's conference for local leaders to convene and collaborate on solutions to the common challenges facing America's cities. Members of Tempe City Council serve on different advocacy committees, councils and boards and participate in task forces and affiliate groups. #### **Arizona Elections Data**

The results for the State Legislative races for the districts that overlap the boundaries of the City of Tempe have not changed from last week's memo. The information was put together by ABC 15 and allows viewers to search for specific races and ballot measures (using the drop down menu in the header) to see precinct-level details of voting proportions.

#### **State Expenditures of COVID Relief**

The Governor's Office announced additional allocations from the CARES Act funding received by the state for COVID-19 related expenditures: \$19 million from the Governor's Emergency Education Relief (GEER) Fund to support education-related efforts including teacher development, teacher stipends, reading and math curriculum, and summer education resources. ## Thanksgiving To-Go

Thanksgiving is a time for family and friends to gather, celebrate, give thanks, and to enjoy a wonderful meal. This year, Thanksgiving celebrations within Tempe's community centers will be different. Unfortunately, as a result of COVID-19, centers are unable to provide their annual in-person events. Instead, Thanksgiving meals will be prepped to-go.



#### **Cahill Senior Center Meals**

In partnership with Rosita's Fine Mexican Food, the Cahill Senior Center will provide a drive-through Thanksgiving meal service from noon to 1:30 p.m. on November 20. City staff and community volunteers will provide car-side delivery service; participants must register in advance to receive a meal. After receiving their meal, participants will be treated to entertainment provided through a virtual platform in the comfort and safety of their home.

500 turkeys have been purchased to meet TCAA and the City's goal of serving 500 families this Thanksgiving season.



## **TCAA Turkey Drive at Escalante**

Through the efforts of Tempe Community Action Agency (TCAA) and staff members at Escalante Community Center, families will be able to receive all of the necessities to make their own Thanksgiving dinner. During the past several weeks, TCAA held a turkey fund drive; in total, 500 turkeys have been purchased to be included as part of a holiday meal box distributed to clients of TCAA.
