<u>Agenda Item 6 – Family Advocacy Center Conversation</u>

• Kiyomi Kurooka presented the Commission with the Master Plan for the future Community Center Campus. They currently have four different site options for the Human Services Building. Plans to make the campus more visible to the Community, providing safer pedestrian walkways and different vehicular/transit routes. This plan included updating the underutilized areas in the campus for the community to enjoy such as shaded areas, more greenery, an area for events, more seating and areas for children and families to play. DWL Architects will be back for the 11/17/2020 Family Justice Commission Meeting. Civil Engineer for Tempe Greg Kent expanded on the timeline for the Human Services Building that being about 5 years. Commission Member Kristen Scharlau preferred the Family Advocacy Center being separated from the Cost estimates, for a short-term Family Advocacy Center, are currently being discussed within the City to present to the Council.

Agenda Item 8 – myPlan app for Domestic Violence Awareness Month

Commission Member Megan Brown presented the myPlan application to the Commission and discussed
how it can be used by those experiencing Intimate Partner Violence (IPV). myPlan provides different
pathways for people to answer questions specific to their relationship or experience and then gives them
information on the severity of the danger in that relationship. There are tools and resources for users to find
within the app to seek help if they may need. Bystanders can use this app if they have concerns for a friend
or loved one being a part of IPV).
