Agenda Item 5 - Legislative Update

The Government Relations Office represents the city's interests at the federal, state and regional levels of government. Through this representation, the Office works to build mutually beneficial partnerships between the City of Tempe and many other entities like Maricopa Association of Governments (MAG) and the League of Arizona Cities and Towns to ensure that the City's perspective and interests are represented in policy discussions and decision making.

The Tempe City Council has prioritized safety, strong community connections, quality of life, sustainability and financial stability in the delivery of City services. The Council reviewed and affirmed support of the 2021 State Legislative Principles, which reflect their strategic priorities, at the November 5, 2020 City Council meeting.

Many legislative proposals have the potential to impact city operations, finances and governance. The two overarching 2021 City of Tempe State Legislative Principles are preservation of local decision making and preservation of existing revenue sources. These principles will act as a guide in the development of policy statements and positions throughout the 2021 legislative session. The first regular session of Arizona's 55th State Legislature begins on January 11, 2021.

Marge Zylla with the City of Tempe Government Relations Office guided members through the State Legislative Update memo provided in the meeting packet. This document highlighted several ways for NAC members to be more informed and get further involved, complete with the appropriate links and included:

- Tempe's Neighborhood Day to connect with the State Legislature, Monday January 25, 2021 from 8:30-10:30 AM (staff will forward out the virtual January mtg. invitation soon) Prior and current NAC members have attended in years past joining their fellow residents and taking time to connect more with activity at the State Capitol, with Mayor and Council and Arizona legislative representatives
- Weekly Legislative Updates (now available to the public through the City Council Weekly Information Packets)
- List-Serve for Legislative Updates
- State Legislative Committees (alerts for fast-moving legislation will be sent out through this list-serve)

Being able to engage with legislators and respond rapidly to proposals as they move through committees is important to make sure the voices of the neighborhoods are heard. Signing up for updates on the list-serve and using the weekly legislative update as a resource can help in having the current information on state policies so you are better able to share your perspectives with our state legislators.

Members inquired what types of issues might come up this session? Marge offered that since the past session was derailed from the norm, some bill progress that stopped will likely be front of line/fast tracked if there is sufficient support to proceed. There are as always, lots of unknowns, and even more so during covid. Some items that could likely come up may include Proposition 208 related taxation changes, affordable housing, short term rentals, and home-based businesses. There could be the potential for covid related bills as well.

Agenda Item 6 - 2021 State of the Neighborhoods Planning - feedback and ideas from NAC member-initiated outreach for possible themes, presentations and activities

Members shared what they had learned from reaching out to their Tempe friend, family, neighbor and work circles. There were a number of different and creative suggestions providing possibilities for the 2021 State of the Neighborhoods and beyond. Workshop topic and theme feedback included:

- Trees care, planting, relationship to climate action
- Live music (possibly outdoors outside of Tempe History Museum)
- Cooking Demonstration or cooking class (ingredients list or kit)
- Family yoga
- Cyber security
- Adaptive re-use (empty retail spaces)
- Helping businesses that had to shut down during pandemic, enticing them to reopen, attracting new businesses
- Tempe Restaurants demonstrate their top meals (maybe with Mayor Woods?)
- Affordable housing
- Crime prevention and statistics
- Areas of concerns
- Social media keeping kids and families safe
- Quarantine projects
- Volunteer activities for kids
- How to support local businesses and charities
- Cooking in the desert
- Affordable Housing
- Gardening in the AZ heat
- Theme Cemetery (Double Butte, Guadalupe), First settlers (150th year since first reference to Tempe)
- Tempe based street artists
- I-phone photography
- Placing Historical photos on a map while guessing where they are taken
- Art class for covid times such as chalk art, free outdoor art, craft with unused masks, workshops on using found objects, recycling - my friend can do found poetry workshop (Commissioner Kurooka)
- Climate Action Plan and neighborhoods in collaboration with Sustainability Commission

After additional discussion, the following possible priorities were identified for additional exploration and follow up.

- 1. **Cooking** local restaurants demonstration or a cooking class
- 2. Trees gardening in desert
- 3. Retail space uses
- 4. Crime prevention
- 5. Affordable housing
- 6. Climate Action Plan and neighborhoods collaborate with Sustainability Commission

Agenda Item 7 - Continuation of NAC 2021 Goals and Strategies Discussion and Refinement

The notes and chart from the November 18 Working Group Meeting attended by Chair Moulton Belec, Commissioners Granillo and Harden, and NAC Retreat Facilitator Aaron Peterson, were provided in the meeting packet. Members discussed the formation of

subcommittees to drill down on specific topics. When finished working on a specific issue or action items, the subcommittee can then pivot to address a different topic.

Chair Moulton Belec offered to make subcommittee assignments based on member backgrounds and shared interests and advised of the expectation of work inside and outside of meetings in order to accomplish commission goals. She added her desire to amplify social media and outreach to residents bolstering and supporting good things that are happening like neighborhood grants. This could be in the form of storytelling and helping to increase the number of applications from areas that have not received a grant in the past.

Agenda Item 9 - Update on Home Occupations Section of Tempe City Zoning Code Related to NAC Input Provided to City Council

Shauna Warner referenced the packet memo regarding Home Occupations and provided members a brief update. The second and final public hearing is scheduled for December 3, 2020. A temporary one-year pilot program is proposed to allow the currently prohibited uses of Beauty Salons and Barber Shops to be permitted. During the pilot timeframe, applications and any complaints received would be tracked. Following the pilot program timeframe, Mayor and Council could then determine whether to extend or make permanent or take other action. Commissioner Larimer asked what the permit or use fee amount is? Staff agreed to find out and report back.
