ACTION: Request approval to abate public nuisance items at the Ngin Pheng Property located at 1371 W. 15th Street. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$2009.00 for abatement request: remove junk, trash, debris and stored items from property.

RECOMMENDATION: Staff – Approval of 180 day open abatement

BACKGROUND INFORMATION: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the NGIN PHENG PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE203393: remove junk, trash, debris and stored items from property.

COMMENTS:

Code Compliance is requesting approval to abate the Ngin Pheng Property located at 1371 W. 15th Street, in the R1-6, Single Family Residential district. This case was initiated 05/19/20, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve a 180 day open abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

1371 W 15TH ST is currently in violation of City of Tempe's Nuisance Code in regards to trash, litter and debris in the front, east side and back yard areas.

The property has been in violation since 05/19/2020 with the initial violation being trash, litter, debris, discarded appliances, discarded furniture, scrap, metals, crates, fence parts, excessive wood, vehicle parts, vehicle tires, shelve(s), bicycle parts in the back yard. There has been minimal response from the owner to clean up the property

The owner **SAMIT NGIN** was mailed correction notices to the property and citations were issued to correct the violation(s). The violation remains unresolved as of this date. Notice of intent to abate was mailed and posted to the owner's property.

RECOMMENDATIONS:

SAMIT NGIN has responded but have not completely attempted to remedy the violation upon the property at 1371 W 15TH ST. Since there has been minimal response, without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Development Services Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code and authorization of multiple abatements for a period not to exceed one hundred eighty (180) days from the previous abatement order. Owner **SAMIT NGIN** has not given any indication that he plans on completely correcting the violation and maintaining the property.

This serves as notification of the City of Tempe's intentions regarding the abatement of code violations on the following described property:

This office will submit this complaint to the Community Development Abatement Hearing Officer to be placed on the Hearing Officer agenda of January 19, 2021 located at the Tempe Council Chambers, 31 E 5th Street, at 5pm. We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

CC 21-3.b.1

Filthy, littered, debris or trash-covered exterior areas, including exterior areas under any roof not enclosed by the walls, doors or windows of any building; including, but not limited to, areas that contain items such as cans, bottles, wood, metal, plastic, rags, boxes, paper, tires, auto parts; unused, inoperable, worn out or discarded appliances or other household items;

If the violations have not been corrected within thirty (30) days, our office will proceed with the abatement process. As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below:

CC 21-3.b.1

Please remove all trash, litter, debris, wood pallets, vehicle tires, scrap, metals, a sink, piles of boxes & buckets, a hydraulic dolly, vehicle parts in the front yard, east yard, back yard porch & back yard areas.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$2008.50. In addition to the actual cost of abatement, an administrative charge of fifteen(15) percent of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the City for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.
