Agenda Item 6 – Welcome New and Re-Appointed Commissioners

 Chair Mary O'Grady thanked past Chair Margaret 'Peggy' Tinsley for her years of service as Chair, and her continued service as a Commission Member. Mary O'Grady also welcomed new Commission Member Mark Perkovich. Commission Members then introduced themselves.

<u>Agenda Item 7 – Discuss and Establish the 2021 Calendar of Family Justice Commission Awareness and Prevention Memorandums</u>

- Commission members discussed continued emphasis on three specific awareness months: Human Trafficking Awareness Month (January), Sexual Assault Awareness and Prevention Month (April) and Domestic Violence and Prevention Month (October).
- Commission Member Kristen Scharlau proposed to add Teen Dating Violence Awareness Month (February) to next year's calendar and memorandum list. Suggestions on how to promote awareness in February included Commission Member Josie Montenegro suggesting she will look into highlighting on the Police Department's social media.

<u>Agenda Item 8 – Discuss and Create Outline for the Sexual Assualt Awareness and Prevention Month</u> <u>Memorandum</u>

 Mary O'Grady offered to create outline for memorandum based on the Commission's discussions. Some topics to be added and/or include updated data are COVID based data, the Family Advocacy Center planning process and discussion on changes made due to budget adjustments.

<u>Agenda Item 9 – Family Advocacy Center Discussion</u>

- The feedback discussed by the Commission in December was given to the developers to continue the Community Center Complex planning process. Deputy Human Services Director Paul Bentley updated the group with two items:
 - Update 1: There are two main options considered in the current planning process. The first is to expand the current Pyle Center to become the new Human Services complex inclusive of the Family Advocacy Center. The second is a new Human Services complex with the Family Advocacy Center included. Both options have been designed to promote privacy, security, and safety
 - Update 2: The City of Tempe Mayor and two City Council Members will be presented with a short-term option in January 2021, to get a Family Advocacy Center up and running as soon as possible. This includes findings and recommendations such as cost estimates to move forward.
