Mr. Doiron pointed to one section in the text about how the stages of aircraft noise increases determine what is considered to be significant within the airport noise exposure contours he found to be the most fruitful. Mr. Tveit recognized members input on the drafted response to the FAA's invitation to submit public input on needs for further research to inform the agency's noise policy. He commented that member input included more attention to the relationship between annoyance and planes being out of their normal flight path has been recommended in the draft statement, and also inclusion of noise impact relative to environmental justice/ socio economic equity.

Motion: Mr. Lynch moved to approve the statement prepared by staff with member input and send it to the FAA. The motion was seconded by Mr. Carraway.
