3. Discussion: Emergency Management Plan (Michelle Seitz, Staff)

Wants functional needs emergency management plan
Federal laws limited for how provide emergency management
Overview of presentation (attached); requested CDC's
thoughts/recommendations/advice/expertise to make sure that developing the plan, exercises,
roles, responsibilities in the best way

Paul: is this new, or how different from what currently exists

Michelle: Within plan, there are sections that focus on functional needs within the plan but no person designated; a collaboration between all responders – have operations section, planning section, resource section (staff, equipment), medical (individuals, healthcare providers – but no specific person within command structure to represent functional needs; new position would be added to focus solely on the functional needs of community members and make determination/decision; even in national incident management system's larger framework, there's not a specific branch dedicated to functional; in past command staff has determined need for specific specialist for specific incident but proposing that have automatic role included

Rene: TPD participates in Smart 9-1-1; people register with Smart 9-1-1 and Tempe Fire has list of those with lockbox or physical disabilities that might need help; asked whether there was question added of whether need help getting out of house in case of emergency but unsure whether question was added; also can add announcement on Next Door to sign up – this is private way to self-identify

Michelle: Writing it down; good to refresh and make sure that it's up-to-date; getting a group together and will bring up these recommendations

Katherine: hiring full-time permanent position

Michelle: when emergency happens and response needed, responders are fire, EMS, PD but they have to collaborate as one and collaborate in the field; open Emergency Operations

Center – gives resources the field needs and give procedures to be followed; EOC that's managing the center have trained for different command roles so can fall into positions when necessary; roles include communications, logistics; these branches only come together when there's an emergency, sit in the position to manage the incident; wouldn't be FT person but someone that already works for CoT and already invested in the community – get educated and trained in the whole system to understand the structure and framework and reporting; EOC closes after incident is over

Rene: do not know if Diablos can fund this year but need to ask them if willing to fund a scholarship, regardless of whether have event

Paul: how got money in past

Irene: Michele submitted request to Diablos in past
