- **December 2020 meeting minute**

- 2) Request a Variance to reduce the separation requirement between tattoo shops from 1,320 feet to 490 feet for VICTORUM TATTOO, located at 516 South Mill Avenue. The applicant is Earl & Curley. (PL210091)

Commission Discussion

Chair Lyon stated that any variance requires four affirmative votes. Since the Board only has six members present at the meeting outside of the full seven. One could argue that it is more difficult to get the four votes. The Board is not required to offer continuance but as a courtesy it has been done from time to time. It is a matter among the Board members to discuss and determine if this is something that they would like to approve or not.

Board Member Baker stated that she would like to know what the date is if it is going to be at the August date or July.

Mr. Abrahamson stated that the meeting date in August is 25th.

Chair Lyon asked the board members if they can attend the August meeting. A few of the board members would not be able to attend the meeting due to other conflict in schedule.

Chair Lyon stated that the Board would consider the meeting date of July 28.

Chair Lyon informed them that the Board is able to do a continuance even if it is not ajenized.

Board Member Confer stated that he has been on the Board for awhile and in the past the Board had trouble getting meetings done because they did not have a quorum. In his opinion since City staff has gone through the process of setting up the meeting and the time for staff to be here and all the agenda items it is a waste of the City money and resources not to have the meeting. have the quorum, he does not see why the meeting can't go as planned. Even though they do not have a full panel they would be able to get the job done.
