Some factors that are required to be ADA compliant include:

- All images, videos and other visuals include alt text
- Color is not used as a navigational tool
- Site includes a "skip nav" option for screen readers
- Web and PDF forms are readable with a screen reader
- Captioning on videos

What we currently have:

- Screen Reader, reads content
- End user can determine the size of the font on their screen
- Homepage: Accessibility button (bottom right) links to the

ADA/Accessibility webpage

- RSS Feed link on Community Dropdown, also added a RSS Feed webpage under ADA/Accessibility
- ** Had Granicus ADA Specialist look at our home page and he reported no issues.

What we are working on to improve:

- All images, videos and other visuals include alt text
- Web and PDF forms are readable with a screen reader
- Captioning on videos
- Site Improve provides dashboard with possible ADA issues
- Audit of the websites, will include looking for ADA issues
