SUBJECT: Update on the Intergovernmental Agreement with the City

of Phoenix for dispatch services provided by the Phoenix

Fire Department Regional Dispatch System



The City of Phoenix began dispatching calls for the City of Tempe Fire Medical Rescue Department (TFMR) in March of 1982 with the implementation of the Computer Aided Dispatching System, and the Automatic Aid Consortium. Currently, with 22 participating jurisdictions, a large expanse of dispatch coverage is provided at a very high level of service. TFMR participates on the Phoenix Fire Regional Dispatch committee which meets monthly to discuss service delivery topics, and to review dispatch service costs.

Although the current intergovernmental agreement was renewed in June of 2019 and remains in effect through December of 2027, the City of Tempe Attorney's Office recommendation is to annually inform the Mayor and Council of the financial impact associated with the agreement in a Friday Information Packet memorandum.

The total amount payable to the City of Phoenix each fiscal year is based on per dispatch cost of service fees, asset maintenance fees, and network system fees. TFMR's total annual dispatch services cost for fiscal year 2021-22 is \$1,428,708; of which \$1,122,762 is paid from TFMR's General Fund budget, and \$305,946 is paid from the Emergency Medical Transportation enterprise fund (EMTF) budget. The General Fund portion is based strictly on costs associated with dispatching services for TFMR's all hazards fire apparatus, while the EMTF portion is based strictly on costs associated with dispatching services for all emergency transportation ambulances providing service in Tempe.

For fiscal year 2021-22 the per dispatch fee increased by \$3.91 or 16% for fire apparatus, and by \$1.63 or 9.5% for ambulance dispatches which resulted in a fiscal year increase of \$87,455 or 8% for the General Fund and \$20,326 or 7% for the EMTF. The City of Phoenix Fire Department provided a memorandum to Automatic Aid agencies explaining the reason for the dispatch fee increases is the addition of 18 new dispatchers to the Phoenix Regional Dispatch Center. The memo cited a 40% increase in calls for service over a ten-year period causing an increase in workload, and indicated the new positions are critical to maintaining call processing times and excellent customer service for the communities served.

Although the entire ambulance share of the annual cost for Phoenix dispatch is appropriated and paid from the EMTF, the City's private sector ambulance contractor reimburses the EMTF on a pro rata basis for its two out of the six ambulances providing service to Tempe. As the City places additional ambulances into service, its share of the annual dispatch services fee will increase accordingly.

SUBJECT: Domestic Violence Awareness and Prevention Month - October 2021

Because October is Domestic Violence Awareness Month, the Tempe Family Justice Commission is providing this memorandum to the City Council and Mayor as part of its responsibility to advise on domestic violence issues.

The Family Justice Commission includes members with backgrounds in social services, law enforcement, education, child welfare, law, health care, and private citizens who care about the issues that the Commission was created to address.

Family Advocacy Center

To begin, the Commission commends the Mayor and Council for the approval of funding a Family Advocacy Center in Tempe. The Center will provide a safe place for domestic violence victims and others to receive the type of trauma-informed care that they need. An important component of the Center is the collaboration with ASU, which will help ensure that it serves the entire Tempe community. The Commission views the approval of the Family Advocacy Center as a major step forward for Tempe.

Domestic Violence Under Arizona Law

Unfortunately, for many, the most dangerous place to be is at home. And people who pose the biggest threat to their safety are household members and family.

By state law (A.R.S. <u>13-3601</u>), domestic violence is a crime defined in part by the relationship of the people involved. It also covers a wide range of crimes – assault, crimes involving sexual conduct, economic, emotional and psychological abuse, property damage and other misconduct are all considered domestic violence depending on the relationship of the people involved.

Relationships covered by domestic violence include those who are or were married, people who are related, people who currently or previously lived together, people who have a child together, and people who are or were previously intimate partners.

Tempe Context

The COVID pandemic resulted in an increase in domestic violence reports, and the numbers have not declined.

In 2020 there were:



- 237 reports of Aggravated Assault/DV which include strangulation, use of a deadly instrument and serious physical injury reported.
 - o 310 individuals were victimized.
 - 135 suspects were arrested.
- 1,250 reports for Misdemeanor Assault/DV.
 - o 1,465 total victims.
 - 628 suspects arrested.

There had been a steady increase from 2016 to 2019 in both areas and the biggest increase was seen in 2019 through 2020.

So far in 2021:

- Domestic violence assaults and aggravated assaults are increasing.
- 124 reports of Aggravated Assault/DV reports.
 - o 152 victims.
 - o 66 suspects arrested.
- There have been 641 Assault/DV reports.
 - o 773 victims.
 - 334 suspects arrested.

Tempe is fortunate to have Care 7, the City's crisis response program, which provides victim assistance and trauma healing services. Care 7 coordinates with first responders to do everything possible to provide trauma informed services to victims as quickly as possible.

The Tempe Police Department Domestic Violence Unit also works closely with Care 7 to maintain constant communication with victims throughout their investigations to help provide the appropriate resources and prevent further victimization. The Domestic Violence Unit is comprised of 5 detectives that work both day and evening shifts to better serve the victims of Domestic Violence.

Outreach, Education and Healing

Victims of domestic violence too often suffer silently. Numerous factors contribute to this silent suffering and not reporting crimes or seeking help. Many of these factors are based in fear, fear of an abuser's retaliation, fear of being blamed for the violence or not believed, fear of losing the main source of financial support to an arrest. A victim may also feel ashamed, crazy, hopeless, or alone, or as happens, there are victims who do not know that they are victims. These barriers can make it difficult to report or to reach out for help.

Outreach to help victims feel safe reporting crimes of domestic violence and services to help them recover from the trauma and rebuild their lives are all part of helping victims of domestic violence. Offender treatment is also important to help prevent future incidents. Education about healthy relationships helps prevent problems from occurring and can help victims recognize when they are in an abusive situation.

This important work is also done by Care 7.

Recommendations

The Mayor and Council are encouraged to:

- (1) Advocate for victims of domestic violence in the month of October and all year long by considering lighting city hall purple, posting recognition of Domestic Violence Awareness month on City websites and social media, encouraging people to wear purple in recognition of Domestic Violence Awareness month;
- (2) Continue to support the Family Advocacy Center so that Tempe has a safe place that provides comprehensive services to victims of crime;
- (3) Continue to support Care 7's victims services and the Tempe Police Department as they support victims of domestic violence.

The Commission is completing its strategic planning process that began in August 2021 to identify ways Tempe can continue to promote access to justice and safety for victims of domestic violence. Additional recommendations for the future will be developed through that process and further reports will be made to Mayor and Council.
