PRESENTATION AND DISCUSSION

HUMAN SERVICES DEPUTY DIRECTOR LEVON LAMY PRESENTED AN UPDATE ON THE HOMETOWN FOR ALL INITIATIVE. THE DISCUSSION FOCUSED ON FUNDING SOURCES FOR THE PROGRAM. COUNCILMEMBER GARLID AND COUNCILMEMBER NAVARRO ASKED FOR STAFF TO PRESENT A POLICY UPDATE TO THE ENTIRE CITY COUNCIL WHICH WOULD ADDRESS THE CONTRIBUTION TO HOMETOWN FOR ALL FROM THE SALE OF CITY OWNED LAND.
