Agenda Item 4 – Regional Transit Fare Collection System

Commissioners asked staff follow-up questions from the Sept. 14 regional transit fare collection system presentation as listed below.

- 1. My question from this morning's meeting around fare collection is a concern for the low income, disabled, elderly (probably all Title VI?) who don't have access to, or the understanding of smart cell phones and loading apps. Will this group just be expected to use cash? I understand the majority of ridership on all the forms of mobility might have access to the media cards without a problem, but I'm still concerned we not neglect this group of riders who are left with no alternative forms of transportation.
- 2. How easy is the application process to get certified/set up an account for reduced fares? I am glad to hear that they are not going to just mobile because many of the people we support do not have a cell phone.
- 3. Phoenix City Councilmember Ansari has recently announced she wants to make public transit fare-free in Phoenix. I can see a scenario where other cities in the Valley Metro system may not necessarily do the same thing even if Phoenix does. How would the new fare system accommodate different cities instituting different fare policies?
- 4. Valley Metro is required to provide a 50% reduce fare, do you know any reason (other than politically) that we can't provide a 100% reduced fare? the regulation seems to indicate we cannot charge more than 50% but doesn't seem to exclude 0% as an option.
- 5. Are you able to determine how much fare revenue was collected in 2019 and how much total was reduced fare passes?
- 6. Also, would you have information about how much it will cost to install TVMs? I was hoping at some point you might have seen a break down of the costs to install and maintain the TVMs.

- 4. "Install buttons for emergency services and on-demand transportation at bus shelters" is listed twice, what was the second option? Could cold water refill stations be an alternative?

PURPOSE

The purpose of this memo is to provide the Commission with an update on the Transportation Demand Management, Transportation Management Association, and the Mobility Hubs Plans.

CITY COUNCIL STRATEGIC PRIORITY

• Quality of Life

- 3.26: Achieve a multimodal transportation system (20-minute city) where residents can walk, bicycle, or use public transit to meet all basic daily, non-work needs.
- 3.27: Achieve a Travel Time Index average at or below 1.25 along major streets during rush hour traffic with no individual segments exceeding 2.0.

• Sustainable Growth & Development

 4.18: Reduce community Greenhouse Gas (GHG) emissions by 80% of 2015 levels by 2050 and achieve community carbon neutrality by 2060.

BACKGROUND

In 2020, city staff applied and received a grant from the Maricopa Association of Governments (MAG) to develop a plan for a Transportation Demand Management (TDM,) Transportation Management Association (TMA), and Mobility Hubs (MH) Plans for the City of Tempe. The TDM Plan would guide the City in how to institutionalize TDM in City processes. The TMA Plan would include a feasibility study and an operations plan for a new organization to assist and partner with the business community in TDM efforts. A Mobility Hub is a place where people can connect to multiple modes of transportation to make their trip as safe, convenient, and reliable as possible. These Mobility Hubs will create a network of locations that provide residents and visitors with transportation choices that can reduce the number of single occupancy vehicle trips in Tempe. The mobility hubs will deliver the first and last mile connection to local and regional transit trips. Mobility Hubs are a type of transportation demand management strategy; therefore, the Mobility Hubs, TDM, and TMA Plans have had a coordinated public and stakeholder outreach effort.

PROJECT UPDATE

The project has successfully enlisted the support and expertise of regional agencies as part of the Technical Advisory Group. Staff from Maricopa Association of Governments (MAG), Valley Metro (VM), Arizona Department of Environmental Quality (ADEQ), Arizona State Parking and Transit (ASU), Downtown Tempe Authority (DTA), Arizona Department of Transportation (ADOT), and Maricopa County Trip Reduction Program are project participants. These stakeholders represent all the agencies that are responsible for transportation, air quality, and sustainability programs in the state and region.

The project has completed presenting and soliciting recommendations from the following:

- Technical Working Group March 2021
- Stakeholder Meeting April 2021
- Tempe Chamber of Commerce April 2021
- Other City Commission Presentations

- Development Review Commission May 2021
- Sustainability Commission May 2021

- TDM/TMA/MH Public Meetings (May 22 and 26, 2021)
- Public Comment Period (March 30 May 31, 2021)
- Sustainable and Livable Council Committee June 2021.

As part of the project discovery process, various community members representing the development community, property owners, board and commission members, social service agencies, Arizona State University, and Downtown Tempe Authority were interviewed individually to solicit specific recommendations that need to be included both plan. Below are some takeaways from the interviews:

- Overall enthusiasm for TDM, TMA, and Mobility Hub options
- Emphasis on educating residents and visitors will be key to the success of any proposed options
- Must incentivize business owners/users, instead of mandating changes
- "Connectivity," "accessibility," "convenience," and "location" were common terms
- Mobility Hubs would work best within a ¼ mile of other hubs/transit options
- Consider first level parking structures for potential sites for Mobility Hubs
- Climate in Arizona is a concern, amenities at Mobility Hubs must consider heat/sun
- Express bus routes/lanes
- Start conversations regarding TDM strategies/MH locations with the developers at "phase one" of a project
- Make parking more expensive/difficult
- Business owners will be interested in the ROI for Mobility Hubs
- Employees showed less interest in cash incentives for using alternative modes in some cases, but showed greater interest in getting compensation for not using assigned parking spot
- Improvement of existing bicycle and pedestrian infrastructure would help increase interest/usership
- Potential resource: The Association for Commuter Transportation (ACT).

The project also had two public meetings on May 22 and May 26, 2021. The project also provided an online comment venue that was open beginning March 30 through May 30, 2021. Key takeaways from the public meetings:

- Many are open to using other transportation options than driving alone
- Bicycle, pedestrian, rideshare, and transit modes are used by respondents
- Pockets within Tempe have convenient transportation choices.

The TDM and TMA Plans (formerly titled Urban Core Alternative Transportation Implementation Plan) received grant funding from MAG in the amount of \$179,200. The City of Tempe Transit Fund provided a local match of \$35,840. The Mobility Hubs Plan also received funding from the MAG in the amount of \$105,041. The City of Tempe Transit Fund provided a local match of \$6,349.



• A 2019 Industry Survey of 100 TMAs Found:

- Top issues that prompted formation and ongoing operation
 - Congestion
 - Employee recruitment and retention
 - Increasing transportation options and choices
 - Incorporating TDM into new development
 - Addressing trip reduction requirements
 - Addressing air quality issues



• A 2019 Industry Survey of 100 TMAs Found:

- Most (64%) have been around for more than 10 years, but there are new TMAs being formed every year
- A large share serve a regional audience (23%) or city/county jurisdictions (16%), while others serve CBDs/downtowns (21%), anchor/activity districts (17%), or suburban business districts (9%)
- Nearly 2/3 are independent non-profit organizations
- Those that are part of a parent organization are most often housed within a government agency (23%), chamber/member org (20%), developer/property owner (16%), or business improvement district (11%)








