3. DISCUSSION:

After learning of the passing of Commissioner Maye, Nanette called each Commissioner then the group discussed the card that was being sent to her parents, on behalf of the City and CDC.

Nanette notified staff that a new Commissioner has been recommended. The group discussed how the selection process happens, if other Commissions help in selecting new ones and the likelihood that it's more feasible that the staff liaison does it.

There was a follow-up discussion about holding the 2022 Mayors Disability Awards Event at the Tempe Center for the Arts on April 12, 2022. With expressed concern related to Covid, Nanette assured the group that many of the same efforts from last year would be repeated for a few reasons. First, those who won the awards and had time with the Mayor had a great experience and it was well received by all. Second, if the event does have to change to a televised program, as it did in 2021, we would already be ready for it. Third, if the footage has already been prepared and the event is held live, it can still be shown before each winner comes up to accept their award and check.

4. PRESENTATION AND DISCUSSION: 2021 CDC ANNUAL REPORT

Nanette showed the group the 2020 Annual Report with rough draft changes for the 2021 report, including accomplishments to potentially list for 2021 as well as goals for 2022. This will continue in its development then be reviewed formally at the December meeting.

5. UPDATES: ADA COMPLIANCE SPECIALIST

Nanette updated and demonstrated efforts on a variety of current efforts including:
