Rob Personale, from the Tempe Diablos, introduced himself and formally presented the news to the group that a check is in the mail for \$4200 to apply towards the 2022 Annual Mayors Disability Awards event. They will also send a picture of the large check handover. The Commissioners thanked Mr. Personale and the Tempe Diablos for the generous donation.

Nanette updated the Commission on the efforts towards this annual event. While Tempe Center for the Arts has been the site for several years, holding the event at the History Museum will afford the flexibility of live attendees but also live recording to stream for those who cannot attend. Mr. Personale stated the Tempe Diablos would like to be kept updated and hope to have representatives attend this event scheduled for Tuesday April 5th, 2022.

4. GUEST PRESENTATION: RON TILLMAN, HEARING LOSS ASSOCIATION OF AMERICA

Ron Tillman introduced himself to the Commission and shared his history with his hearing loss. He discussed efforts of the Hearing Loss Association of America and their monthly meetings held at various times based on chapters. He reported being part of the Nov. 6th Walk 4 Hearing that included 400 participants and raised over \$56,000.

Mr. Tillman encouraged the group to learn more and informed them of the June 23-25th HLAA Annual Conference being held in Tampa Florida next year.

He answered questions by the Commissioners and made himself available for future contact.

5. PRESENTATION AND DISCUSSION: 2021 CDC ANNUAL REPORT

Nanette showed the group the 2021 Annual Report, including a summary of 2021 and accomplishments then 2022 goals for discussion. For both of these, the focus is around City Councils Strategic Priorities:
