3. DISCUSSION:

CDC Chair, Katherine Schmidt reminded the Commissioners that elections for Chair and Vice-Chair will be held in February and encouraged them to consider nomination options.

Kathy Jefferson introduced herself as the newest Commissioner. She reported living in Tempe for over 30 years and working in the disability field for over 20 years.

4. GUEST PRESENTATION: RUTH-ANN STROM, TEMPE ARC

Ruth-Ann Strom introduced herself and talked about efforts of the Tempe ARC to serve the needs of the disability community, especially amidst Covid-19. She reported that their efforts shifted to virtual programming last year and this has been very successful. For example, they have virtual art lessons that are held after staff drop off art packets to members around the valley. They also hold virtual dances that have included people from all over the valley who may not have ever attended before due to transportation challenges, etc.

Currently, they are looking to lease space to eventually hold more programming when distancing concerns are reduced.

Ms. Strom answered questions by the Commissioners and provided links for them to contact her.

5. Presentation and Discussion: 2022 Mayors Disability Awards EventWith a draft of the 2022 Nomination packet previously sent to the

Commissioners, feedback was discussed and changes to the document were made during the meeting. Changes included:

- Simplifying the document to about 1 page that would be embedded into emails and on the website, linking to the actual online form.
- Removing, relocating or simplifying some of the language under "Eligibility Requirements".
- Including a step-by-step process which mentions the post-nomination request for pictures and video recorded interviews of nominators only after the nominee has been accepted.
