

RESOLUTION NO. R2022.47

**A RESOLUTION OF THE CITY COUNCIL OF THE
CITY OF TEMPE, ARIZONA, DECLARING THE
CANVASS OF RESULTS FOR THE CITY OF TEMPE
GENERAL ELECTION HELD ON MARCH 8, 2022.**

WHEREAS, by Resolution No. R2019.87, and under the authority of Tempe City Charter, Article VII, the Tempe City Council dispensed with the City of Tempe Primary Election and ordered that the City of Tempe General Election be held at the time that the Primary Election would otherwise have been held; and,

WHEREAS, the General Election was held and conducted in the City of Tempe, Arizona, on Tuesday, March 8, 2022, for the purpose of electing candidates for three Council seats; and,

WHEREAS, by Resolution No. R2021.87, the City of Tempe conducted the General Election as a ballot by mail election; and

WHEREAS, it now becomes the duty of the City Council of the City of Tempe, Arizona to canvass the election results of the March 8, 2022 General Election;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF TEMPE, ARIZONA AS FOLLOWS:

Section 1. That Exhibit A, attached, is declared and adopted as the official canvass of votes of the March 8, 2022 General Election and includes:

- 1) the overall citywide voter turnout;
- 2) the number of ballots received by precinct;
- 3) the number of ballots rejected by precinct;
- 4) the titles of the offices voted for and the names of each person voted for to fill the offices;
- 5) the citywide number of votes and overall percentage of votes received by each candidate
- 6) the number of votes by precinct received by each candidate;

Section 2. That, as shown in Exhibit A, the total number of ballots cast in the March 8, 2022 General Election was 21,338. The total number of registered voters was 101,822, resulting in a 20.96% voter turnout rate.

Section 3. That the names of the candidates voted for at the March 8, 2022 General Election for the office of City Councilmember were:

Arlene Chin
Casey Clowes
Berdetta Hodge
Gina Kash

Harper Lines
John Skelton

Section 4. That Jennifer Adams, Arlene Chin, and Berdetta Hodge, received the highest number of votes, are declared elected to the office of City Councilmember, as of the March 8, 2022, General Election, with terms of office commencing at the first regular meeting of the City Council in July, 2022, and are hereby issued certificates of election.

Section 7. That the City Clerk shall enter Exhibit A on the records of the City of Tempe as the official canvass.
