# Smith Innovation Hub and Tempe Maker District Design Guidelines Update

Presenters: Jill Buschbacher and Ambika Adhikari, City of Tempe and John Kane, Architekton

Ms. Jill Buschbacher, Economic Development Program Manager, advised that this project began in October 2021, and they are currently in the development and public input stage.

Mr. Ambika Adhikari, Principal Planner, advised that these guidelines will go into more specifics and details about the design of the buildings.

Mr. John Kane, Architekton, advised that the Smith Innovation Hub is unique as it is close to ASU, has a nearby light rail and streetcar, freeway access, and some unique light industrial uses. The Tempe Maker District is about one square mile, with more manufacturing and distribution type uses which results in more trucks. They have conducted public outreach such as meeting with the Arts and Culture Commission, the Sustainability Commission, and held a Maker District public neighborhood meeting where there were 21 attendees, and the Smith Innovation Hub, where there were 13 attendees. Along with other suggestions, everyone agreed on improving walkability in the area. They will have a formal DRC hearing and then proceed to the City Council. Mr. Kane went over the table of contents for the guidelines to illustrate what is included. The design guidelines are a set of principles that are aimed at developers, architects, review boards, etc. to guide the transformation of the hub.

Commissioner Lloyd asked what the plan is to promote this and put it into action with the current state of the market, where there is no vacancy, it is very tight, and there may not be much turnover in the existing buildings. Ms. Buschbacher stated they see this as a long-term play and have been working in the Smith Innovation Hub on a long-term master plan that was approved by the City Council last month.

Commissioner Amorosi asked if they are going to target certain areas to make them more park-like so they will go there. Ms. Buschbacher noted that open space is important in these areas, and the master plan is encouraging this, however the City does not own any land or buildings in this area.

Commissioner Sumners asked what steps are being taken to protect some of the industrial uses. Ms. Buschbacher advised that each project will be looked at as they come in on a case-by-case basis to make sure the uses are compatible, so they do not encroach on existing, successful businesses.

Commissioner Redman applauded what they are doing for sustainability but asked what other similar things they plan to do. Mr. Kane advised they are looking at walkability, green infrastructure, etc.
