**Agenda Item 5 – Chair Remarks**

**Agenda Item 6 – Victim Awareness Campaign-Public Space Signage Update-Commission Member Jeanette Costa**

Commissioners Costa and Stinchfield met with COT Public Information Officers Ripley and Steckner to discuss the outline and the mission goals that a COT-produced awareness signage should have. Along with a focus on ease and comprehension, the commissioners and PIOs discussed the information that the signage should provide. PIO Steckner will produce a draft signage and give it to the Commission for review and discussion.

**Agenda Item 7 –Discuss and Plan Department of Child Safety Presentation**

The Commission is committed to its role and would like to be able to provide better advice to the Mayor and Council. As such, the Commission is interested in knowing more about what State and Local Departments are doing at the moment to combat domestic violence. One department of interest is the Department of Child Safety (DCS). They would like to invite a representative to address the Commission.

-Commissioners spoke at length and with interest over DCS' role in many situations. Ideas around prevention, advocacy, education, and resources colored the commissioners' interest. Moreover, the commissioners discussed the correct terminology that DCS uses; commissioners would like to know the standards that DCS looks at when dealing with potential neglect. Additionally, what resources are afforded to families once DCS identifies them as a potential household of neglect?  
-Finally, if DCS could provide information on Tempe households, the Commission would find this beneficial.

**Agenda Item 8 –Discuss Current Counseling Services Access/Opportunites for the Community**

Commissioner Oliver spoke in detail about the current lack of meaningful and productive mental health services at ASU. She outlined ASU's role in addressing victims' needs and the current structure found at the university. Moreover, Commissioner Oliver also mentioned recent conversations she had with ASU's victim officers; they highlighted the need for cooperation with COT and their role in the Family Advocacy Center.

**Agenda Item 9 – Discuss and Plan Future Meeting Attendance Options**

Virtual meetings will stay commonplace until decided otherwise. Hybrid options may become an option later on, potentially when the Commission has a guest speaker.
