# Agenda Item 6 – Welcome New Commission Bjorg Lesueur

The commission is excited to welcome its newest member, Bjorg LeSueur. She is a clinical faculty at ASU; she has a background in early childhood education. The commissioners are eager to have her insights, and they look forward to working together

# <u>Agenda Item 7 – Arizona State University Sexual Assault and Relationship Violence Prevention Program Presentation</u> and Discussion

Through commissioner Oliver, the commission welcomed two guests from Arizona State University's Counseling & Sexual and Relationship Violence Prevention(SRVP) sector, Caroline Monica and Kimberly Frick.

-Caroline Monica spoke in-depth on the School's role in supporting mental health across its campuses. There are multiple ways ASU tries to help students. Some divisions help students with long-term care find help around the valley, and others focus on supporting students in emergencies and same-day support. These structures are staffed with highly trained and certified public and mental health professionals. Individuals seeking help are also given the opportunity to speak to someone who can recognize and understands their intersectionality. Another way ASU is trying to help its community is by supporting and promoting programs like Devils-4-Devils, online peer-led conversations. The tools available at ASU are extensive and vary greatly, but they are committed to helping individuals.

-Kimberly Frick spoke in-depth on ASU's Sexual and Relationship Violence Program. She touches upon the program's longevity and how ASU requires students to learn about the topic in-depth. This preventative education is taught on campuses, and it is required from athletes, social clubs, and dorm supervisors. SRVP believes that educating students and empowering them to call out and prevent abuse is key to decreasing abuse. Additionally, SRVP tries to support individuals through support systems and online resources. These resources take advantage of tools offered by the COT and do a lot to support students in any given situation they may find themselves in.

The commission was enthusiastic following the presentations, and they were excited by the extensive role it has tried to take on

# Agenda Item 8 – Victim Awareness Campaign – Public Space Signage Update – Commission Member Jeanette Costa

Commissioner Costa presented the rough draft of a poster for victims' advocacy of domestic abuse in public spaces. She has been working with the City's PIOs to produce this poster but mentioned that it is still being worked on. Commissioner Costa mentions the need to have inclusive material that victims can notice.

-Commissioners reacted positively to the work that has been produced; their suggestions were centered around wording and visual cues that might helps victims recognize their reality.
