Agenda Item 5 – Chair Remarks

Chair O'Grady did not have any remarks at the moment.

Agenda Item 6 - Economic Development, Introducing the Hayden Flour Mill Redevelopment

The Commission welcomed Maria Laughner from the COT's Economic Development department, Andrea Alley and Lorenzo Perez from Venus Projects, and Heidi Kimball from Sunbelt Holdings. They join the meeting to discuss plans for the redevelopment of the Hayden Flour Mill.

Heidi and Lorenzo discussed at-length different projects found across the country that could serve as inspiration for the redevelopment of the site. They also mentioned the need to respect the original site's history, the butte's cultural significance, and the importance of the location providing private and public space for individuals visiting the site. Any additional structures that may be added will be secondary to the existing structure and will serve to enhance the Mill Avenue experience. In terms of securing finance for such a project, the goal is to build a partnership between private and public capital. The project also hopes to utilize varying financial incentives from both the national and state level.

This project is at its genesis, and it is believed that it may take 3-5 years after the initial planning and development are complete. Its location and age subject the site to maintenance and a historical inquiry, so these factors could prolong any development.

Agenda Item 7 – Victim Awareness Campaign – Public Space Signage Update – Commissioner Jeanette Costa

The development of the public space signage is progressing. Commissioner Costa is in continuous contact with Susie Steckner over the design and distribution. The goal of distributing it across Tempe by October (Domestic Violence Month) is still on track.

Agenda Item 8 – Discuss and Plan Department of Child Safety Presentation

-Commissioner Tinsley discussed her experience reaching out to various state and local agencies, including the Department of Child Safety (DCS). The experience demonstrated to Commissioner Tinsley various issues with communication between agencies in Arizona. Moreover, Commissioner Tinsley believes that some current structures that lead victims directly to their local police department may hinder victims' willingness to seek help.

-Commissioner Tinsley did find the assistance from Mesa and Scottsdale representatives helpful. They mentioned their centers' participation in a state-wide meeting of advocacy centers as a way for agencies to interconnect with different practices. Still, while it seems natural that DCS would attend these meetings, they do not.

-There is hope that DCS can be present at the upcoming Tempe Advocacy center.

-The Commission hopes that it can visit a local advocacy center to gather more information on their practices and their connections with intra-city departments.

Agenda Item 9 – Family Advocacy Center Update and Discussion

As of June 9, the COT has officially approved leasing a local facility that will serve as Tempe's Advocacy Center. The desire is to have the center fully functional by October, but some services will be available sooner. Currently, the center is divided into two sections; one will be headed by Tempe PD and the other by Human Services. The former will be able to provide services sooner than the latter (its section requires major remodeling). The services that will be provided are already available. However, the center's goal is to streamline the sometimes disjointed roles that different departments provide to victims of domestic abuse.

-the Commission can have a tour when greater remodeling is complete.
