
Agenda Item: 2

ACTION: Request approval to abate public nuisance items at the Chavira Property located at 1401 E. Stephens Drive. The applicant is the City of Tempe – Code Compliance.

FISCAL IMPACT: \$2318 for abatement request: remove dead fronds from palm trees on the property.

RECOMMENDATION: Staff – Approval of abatement

BACKGROUND INFORMATION: City of Tempe – Code Compliance Section requests approval to abate items in violation of the Tempe City Code at the CHAVIRA PROPERTY. The details of this case represent several months of correspondence for compliance with the property owner. Staff requests the approval of abatement of the following nuisance items under Complaint CE220522: remove dead fronds from palm trees on the property.

COMMENTS:

Code Compliance is requesting approval to abate the Chavira Property located at 1401 E. Stephens Drive, in the R1-7 Single Family Residential district. This case was initiated 01/24/2022, after which Code Compliance has attempted to obtain compliance through correspondence with the property owner regarding violations of the Tempe City Code.

Without the intervention of abatement, the property will continue to deteriorate. It is therefore requested that the City of Tempe Community Development Hearing Officer approve abatement of this public nuisance in accordance with Section 21-53 of the Tempe City Code.

FINDINGS:

01/24/2022 The Code Compliance Division received a complaint for this property for overgrown palm trees in the back yard of the property. An inspection confirmed that there were several palm trees in the back yard with dead palm fronds that are in violation of the landscape code. A notice was mailed to the current owner, Leandro Chavira.

02/24/2022 Inspected the property, and the trees were still in violation. A final notice was mailed to the property owner.

03/28/2022 Reinspected the property. The property was still in violation. A pink hanger was hung on the front door requesting the owner to come into compliance or contact me by 4/1/2022 to avoid a citation.

04/01/2022 Received a phone message from Mr. Chavira. He said he was working on the trees. Granted him until 4/11/2022 to complete the trees and asked him to contact me if he needed more time.

04/11/2022 Mr. Chavira called and requested another week. The time was granted.

04/25/2022 Issued citation #1702577 for the violation of overgrown palm tree fronds. Pictures were taken to show the condition of the property.

05/20/2022 Turning in the paperwork to abate the property. The hearing is set for July 5th. 2022.

RECOMMENDATIONS:

I recommend an abatement of the nuisance violation at the property located at 1401 E. Stephens Dr, due to property owner's failure to bring property into compliance with Tempe City Code 21-3. b.8. Leandro Chavira was issued a citation and did not pay for the fines and has not brought the property into compliance. The property represents an eyesore to the community.

Without the intervention of abatement, the property will continue to deteriorate. I therefore make a request to the City of Tempe Community Development Hearing Officer for authorization to abate this public nuisance in accordance with section 21-53 of the Tempe City Code.

We are requesting Hearing Officer Authorization to abate this public nuisance in accordance with Section 21-53 of the Tempe City Code by removal and repair of:

As owner of the property, you have thirty (30) days after receipt of this letter to abate or correct any violation as described below. If the violation(s) have not been corrected, our office will proceed with the abatement process.

PLEASE TRIM OFF ALL DEAD PALM FRONDS FROM THE PALM TREES IN THE BACK YARD OF THE PROPERTY.

Upon receipt of the Hearing Officer approval to abate this public nuisance, the necessary work will be performed at the expense of the property owner. The cost of this work will be \$2318.00. In addition to the actual cost of abatement, an administrative charge of fifteen percent (15%) of the actual cost of abatement or three hundred (\$300) dollars, whichever is greater, for expenses incurred by the city for abatement procedures, and the cost of recording liens and releases will be charged. The recorded lien may bear interest at the legal rate of judgments in the State of Arizona. Administrative charges and the cost of recording liens and releases shall become a lien on the property whether or not the public nuisance is abated by the City.




