Agenda Item 1 – Call to Order:

Agenda Item 2 – Approval of Board Meeting Minutes:

Motion by Jerry Hart to approve May 23, 2022, Board meeting minutes with corrections; second by Robin Arredondo-Savage. Motion passed on a vote of 4-0.

Agenda Item 3 – Alliant Renewal Update:

Shawn and Pamela from Alliant presented the following excess insurance coverages for approval by the RMTB. The total premium for all programs in the fiscal year 2021/2022 was \$2,775,124. The fiscal year 2022/2023 insurance premium for coverages is estimated at \$1,130,467; however, it does not include General Liability and Cyber insurance coverage.

The RMTB approved the excess insurance coverage presented by Alliant and recommended it be sent for Council Approval at the June 23 Regular Council Meeting. Alliant introduced a new program for RMTB consideration: Alliant Deadly Weapon Program. This program provides 1st and 3rd party coverage, including crisis response for active shooter incidents. While this new program is worth exploring, the RMTB requested more information after seeing the General Liability and Cyber insurance coverage premiums. Chris Hansen reported that the current crime insurance policy is a three-year policy that is in its last year and will expire in July 2023. Also, the drone coverage expires in November 2022. Quotes will need to be obtained. The RMTB will discuss any aviation or drone coverages for a mid-term October Council consideration.

Agenda Item 4 – June 23rd Council Meeting Agenda Items:

Chair Duensing stated we are late in the fiscal year, and any items due for council approval will need to be submitted tonight, June 16. Tentatively on the June 23rd Regular Council Meeting Agenda are two items:

- A resolution that gives the city manager the authority to administratively approve any excess insurance coverages that the RMTB does not get through during the June 16 Meeting. The intent is the bring any excess insurance coverages approved administratively back to this RMTB for discussion and ratification at the next available Regular Council Meeting in August.
- 2. Approval of excess insurance coverages that the RMTB approved during the June 16 meeting.
