3. WELCOME NEW COMMISSIONERS

Rachel Gomez and Julie Malloy each introduced themselves and talked briefly about their own experiences in the disability field.

4. Presentation and Discussion: Transportation Dept.

Under Transportation and Planning, Chase Walman gave an overview of Tempe's Transportation Masterplan and one of Tempe's Transportation Demand Management Strategies, Mobility Hubs. He stated that the City will prioritize the implementation of these Mobility Hubs in defined Equity Need Areas.

Mr. Walman then gave an overview of five capital improvement projects that are in various stages of Design and Construction. These projects included the El Paso Multi-use Path and Alameda Drive Streetscape projects which are currently under construction. He went on to detail three more projects that are in the design phase which included the Grand Canal Connection Project, Country Club Way Project, and the North South Bike/Ped Project. - Some of the challenges facing the transit industry and the region at large
- Update on the Transit Shelter project to upgrade and install new and improved shelters

5. Presentation and Discussion: Rolling Hills Golf Course

After background information from Julie Heitter and Craig Hayton, representatives from Grass Clippings presented on their concept to modify the Rolling Hills Golf Course, add programming, modify the course, increase usage time and accessibility. They are in the process of gathering public and Commission feedback and questions. Some of the questions and feedback from the group included:

Questions:

- What is the lighting situation? Is there any light pollution into the zoo? How tall are the light poles? What are the hours of night play?
- Are you renovating the clubhouse?
- Are you renovating the golf course bathrooms? Strongly suggested to increase accessibility.
- Can you go to the lookout point without playing golf?
- How do you lower the barriers for people with disabilities?
- How is the property going to be accessible to people with disabilities?
- Is this accessible to low-income people?

Feedback:

- An ADA survey was recently done. Checking permission to share results with Grass Clippings
- · Happy to see family activity lawn appeal to kids and families
- Strongly recommended adding an adult changing table to the property, that allows for self-operated height adjustments
- Only provide movies and programs that include subtitles/captioning to the outdoor viewing screen
- The site sits right down the street from Mobility 360—Host disability events here
- Provide accessible golf carts
- When adding parking, include at least the minimum scope required for ADA parking (if not more) but also ensure it is Universally Designed ADA parking that includes 11' spaces and shared 5' access aisles.
- Include an ADA compliant and accessible passenger loading zone to better assist with arrival and departure of buses, vans,
