Agenda Item 6 - Victim Awareness Campaign- Commissioner Jeanette Costa

October is National Domestic Violence Awareness month. One way the commission has decided to participate is by producing and distributing public signage to serve victims of domestic violence. Commissioner Costa has been in contact with a Tempe

PIO, Susie Steckner. At the same time, the signage production has been lagged on the design side; Commissioner Costa is hopeful that it will be ready by October.

-The commission is steadfast in its believe that public signage should be inclusive, help victims identify themselves, and provide information to help them. Moreover, the commission talked about the information that should be conveyed. The notion of pull tabs, QR codes, and other manners of information distribution were discussed. The commission wants all individuals to have access to this information

Agenda Item 7 – Discuss and Plan Future Strategic Planning Retreat

The commission began discussing its future plans. Deputy Bentley commented that Human Services' Sr Management Assistant is willing to assist the commission's Strategic Planning Retreat. Moreover, Deputy Bentley mentioned the possible need for a long planning session that will allow the commission to plan their work and scope, similar to prior years. -The conversation also covered a series of different topics. One is the presence of guest speakers and how their expertise can help the commission better visualize the objectives. With the pending opening of the Family Advocacy (FA) Center, the commission expressed interest in how other communities approach their work through their FA Centers. Commissioners voiced their varying interests and thoughts on the issues.

Agenda Item 8 – Discuss and Plan City of Tempe Diversity Office Presentation

-In previous sessions, the commission had expressed its desire to have a representative from the COT's Strategic Management and Diversity address the commission and discuss the reality that are present in Tempe. However, such an invitation had been postponed due to the department's ongoing reorganization.

-Additionally, commissioners posed questions about the COT's method of addressing and speaking with an individual of varying gender identities, ethnic backgrounds, religious creed, language, or other diversity identifiers. With this information, the commission believes that their work can benefit and potentially reveal blindspots that commissioners may have.

Agenda Item 9 – Family Advocacy Center Program Update and Discussion

Commissioners were hopeful upon hearing about the FA Center's progression. They expressed their desire to visit the facility and inquired about the daily operations the center will carry out. Deputy Bentley informed the commission of the Human Services objectives at the FA center. He also mentioned Tempe PD's role at the center and their relationship with Human Services. Also, Bently informed the commission of the new services provided when an individual calls 911. Rather than most calls resulting in police presence at the scene, these new services will allow for individuals experiencing a personal crisis to speak to a professional who can help them.

-Also Care 7 will maintain its current location, but will be present in the FA center
