# Agenda Item 6 – Victim Awareness Campaign – Public Signage Update – Commission Member Jeanette Costa

Commissioner Costa presented a draft of the Domestic Violence Victim Awareness poster.

Susie Steckner answered questions from Commissioners about language and design.

The Commission expressed intent to have an early version of the poster printed and distributed for Domestic Violence Awareness Month.

Commissioners discussed creating multiple versions of the poster, representing human diversity in the graphics.

# <u>Agenda Item 7 – Domestic Violence Awareness and Prevention Month Draft Memorandum Review and Discussion – Commission Member Peggy Tinsley</u>

The Commission reviewed and discussed the draft memorandum produced by Commissioner Tinsley.

The draft was edited by the Commission.

The Commission was still awaiting the confirmation of additional facts and figures from Tempe Police Department.

# <u>Agenda Item 8 – Tempe Police Department Quarterly Data Review</u>

Tempe Police Commander William Cullins presented the 2022 Quarter 2 statistics on the Commission's crimes of interest. Commander Cullins reported that Domestic Violence statistics are down, while child crimes increased. Commander Cullins also noted that overall property crime and violent crime has increased.

Commander Cullins hypothesized that the statistics reflect the effects of the Covid-19 pandemic. Mr. Bentley concurred. Commissioners Oliver and Tinsley asked if the crime data can be broken down by age and ethnicity. Commander Cullins informed that he did not currently have that data pulled, but it is possible to obtain the information.

# Agenda Item 9 - CARE7 Quarterly Data Review - Commission Member Anastasia Stinchfield

Commissioner Stinchfield presented the 2022 Quarter 3 data for CARE7's Victim Services.

Commissioner Stinchfield introduced Sully, the therapy dog.

Commissioner Stinchfield informed that Victim Services attempts to keep victims with the same victim advocate each time they utilize the program's services.

Commissioner Stinchfield reported that referrals to Victim Services come from the CARE7 Crisis Team, Tempe Police Department, and Tempe Court. The commissioner stated that 23 victimization types are tracked by the department. Commissioner Stinchfield reported that 6 victims were housed in the Victim Service department's temporary shelters this quarter.

Commissioner Stinchfield noted that statistics for Victim Services do not match the Tempe Police Department statistics because victims do not always report crimes committed against them.

#### Agenda Item 10 – Discuss and Plan Future Strategic Planning Retreat

Mr. Bentley announced that the Strategic Planning Retreat will be on Monday, September 26, 2022 from 9:00 am to 1:00 pm and Commissioners are encouraged to attend in-person, but remote attendance will also be an option.

Mr. Bentley stated that Commissioners will discuss focus questions to plan for the Commission's upcoming year.

Mr. Bentley advised the Commissioners to review the powers and duties of the Commission to guide the future planning process.

#### Agenda Item 11 - Tempe Family Advocacy Center Program Update - Anastasia Stinchfield

Commissioner Stinchfield gave an update on the Family Advocacy Center (FAC). The FAC building is expected to be complete on October 7, 2022.

Commissioner Stinchfield mentioned that the FAC features an art room, as well as a place for court services, where victims can obtain orders of protection.

# Agenda Item 12 - Commission Member Updates

Commissioner Costa requested that the Commission approve to get a version of the Domestic Violence Awareness posters approved and distributed to city buildings for Domestic Violence Awareness Month in October.

Mr. Bentley suggested that the Tempe Family Justice Commission be named on the Domestic Violence Awareness posters.
