Request a General Plan Projected Land Use Map Amendment from "Commercial" to "Mixed-Use" for approximately 34.4 acres; a General Plan Projected Density Map Amendment from "No Density" to "High Density – Urban Core" (more than 65 du/ac) for approximately 34.4 acres; a Zoning Map Amendment from R1-6 and GID to MU-4 for approximately 46.27 acres; and a Planned Area Development Overlay to establish development standards and varying heights up to 129 feet, 2,100 dwelling units and commercial consisting of a multi-purpose entertainment facility, retail, restaurant, hotel and office uses for the TEMPE ENTERTAINMENT DISTRICT, located at 53 S.
