# ESSENTIAL JOB FUNCTIONS

Essential job functions are the fundamental duties of a position: the things a person holding the job absolutely must be able to do.

To actively support and uphold the City's stated mission and values. To perform a variety of skilled technical duties and tasks in the operation, maintenance and testing at the City's water or wastewater treatment plant facilities, as assigned. Monitor plant functions, collect samples, perform laboratory testing and adjust chemical feed rates and equipment to adhere to regulatory requirements.

#### OTHER DUTIES AS ASSIGNED

Please note this job description is not designed to cover or contain a comprehensive listing of all activities, duties or responsibilities that are required of the employee for this job. Duties, responsibilities and activities may change at any time with or without notice.

- Follow safety regulations and safe work practices at facilities, including traffic/barricade compliance and confined space entry procedures; adhere to all Occupational Safety and Health Administration and water treatment guidelines.
- Perform skilled work in the operation of groundwater production wells, water storage facilities, water or wastewater treatment plants and water distribution systems.
- Take lead in applying treatment process control directives, perform troubleshooting activities, act as a technical resource to others, provide training, manage inventory, manage regulatory records and use a computerized maintenance management system.
- Respond to customer inquiries or refer them to the attention of a superintendent.
- Follow laboratory procedures and practices; evaluate treatment processes, such as pH, jar testing, residual chlorine, turbidity, chloride, total alkalinity, total hardness, calcium hardness, magnesium hardness, temperature and residual fluoride.
- Oversee the operation and maintenance of plant equipment and processes related to water and wastewater treatment systems; that include reclamation and advanced water treatment.
- Demonstrate and utilize complex technology for assigned treatment facility.
- Lead special projects as assigned and coordinate functional and/or technical activities, direct staff and prioritize activities between the different treatment facilities, including the operation of valves, gates, pumps and equipment.
- Maintain and update operation and maintenance manuals, records and logs.
- Review compliance and process data and trends to identify variations in the treatment process; make appropriate adjustments.
- Assist in maintaining day-to-day operations necessary to meet all required local, state and federal rules and regulations and comply with operating and safety standards.
- Conduct facility tours.
- Draft Standard Operating Procedures (SOPs), Job Hazard Analysis (JHAs), memos and reports as directed or required.
- Adhere to SOPs, JHAs and Safety Data Sheets.
- Assist with the scheduling and delivery of materials and chemicals and the removal of hazardous by-products.
- Maintain all qualifications to fill temporary duties as Direct Responsible Charge (DRC) of assigned facility.

- Perform Confined Space Entry duties as entrant, attendant and/or Authorized Entry Supervisor as plant duties necessitate.
- Perform related duties as assigned.
