# DEFENSIVE DRIVING CLASS

If you qualify for the defensive driving diversion option, it may be applied to **only one** eligible traffic violation. You must address any additional violations, by the appearance date on your complaint. If you receive an extension to complete a defensive driving class, it <u>only</u> applies to the eligible violation.

## ADVANTAGES:

- 1. The violation will be dismissed.
- 2. You will receive no points against your license for that violation.
- 3. You will not have to pay the sanction amount due.

# ELIGIBILITY:

You may be eligible if you meet all of the following requirements:

- 1. You have not attended a defensive driving class in the State of Arizona for dismissal of a traffic violation within the past twelve (12) months (violation date to violation date).
- 2. A violation code on your complaint matches one that is noted with an asterisk (\*) in the SANCTION SCHEDULE below.
- 3. Your traffic violation did not result from an accident involving death or serious physical injury.

Note: a commercial driver's license holder is eligible only if the individual was driving a vehicle requiring a class D or a class M license and the vehicle was not being used for commercial purposes.

# WHAT TO DO:

- 2. Complete the class **at least seven business days prior** to the court date written above your signature on the complaint.
- 3. You MUST bring the following to the class:

Driver license, copy of the complaint, money order/cashier's check. Failure to complete the defensive driving class AT LEAST SEVEN BUSINESS DAYS PRIOR to your court date will cause additional monetary penalties to be imposed and a possible hold on renewal of vehicle registration.

## YOU MUST APPEAR IN COURT IF:

- Any violation code on your complaint does not appear on the sanction schedule below.
- Your complaint was issued as a result of an accident involving death or serious physical injury.

Failure to appear in court on or before the court date listed on your complaint may result in the issuance of a warrant for your arrest, additional monetary penalties being imposed and a possible hold on renewal of vehicle registration.

# SANCTION SCHEDULE

Listed below are VIOLATION CODES with total amounts due. Total amounts include mandatory surcharges and fees. An asterisk (\*) indicates the violation is eligible for the defensive driving class or the Bicycle Diversion Class if cited while riding a bicycle. If payment is not received by the court date provided on your ticket, there will be a

\$20.00 time payment fee per case, plus an additional \$50.00 on <u>each</u> violation which is included in the Default Amount column below. Collection fees are also added to the default amount.

NOTE: It is your responsibility to ensure that any correspondence sent to the Court has been received and includes a written explanation of the purpose of the correspondence. Notify the Court of any address changes.

#### IMPORTANT NOTICE for individuals cited for:

**A.R.S. 28-645A3A – Red Light Violation & A.R.S. 28-647.1 – Flashing Red Stop Signal:** Persons found responsible or entering a plea of responsible, will be ordered by the Motor Vehicle Division (MVD) to attend and successfully complete Traffic Survival School (TSS). If you are eligible for defensive driving school and complete the class, the violation will be dismissed, and you will not be subject to the requirement to attend a TSS class by the MVD.

**<u>A.R.S. 28-2532A</u>** – **No Vehicle Registration** Violation dismissed upon proof of current registration.

<u>A.R.S. 28-2322</u> – Expired Non-Resident Vehicle Registration Provide proof of current registration for reduced total amount due of \$167.00. Payment must be received by your court date.

**<u>A.R.S.</u>** 28-3169A – No Driver License in Possession Violation dismissed upon proof of driver license valid on the date and time of the violation.

**A.R.S. 28-907A & B** – **Child Passenger Restraint** If you have been cited for "failure to use," or for "failure to equip", the total amount due is \$227.00. However, upon completion of a child safety course, offered through Tempe Police Department, the total amount due will be reduced to \$0.00 and you may receive a free child restraint system. For information, call 480-350-8376.

A.R.S. 28-4135A - No Mandatory Insurance The total amount due ranges from \$1039.00 to \$1938.00 If you present proof of purchase of a 6 month current insurance policy and a copy of your MVD record showing no convictions for violating A.R.S 28-4135 within 24 months prior to the date the complaint was issued, or only one conviction for violating A.R.S 28-4135 within the 36 months prior to the date the complaint was issued the total amount due may be reduced to \$226.00. A.R.S. 28-4135B & C - No Proof of Insurance The total amount due ranges from \$1039.00 to \$1938.00. If you mail or fax proof showing that the vehicle involved was insured on the DATE and TIME the complaint was issued, the violation will be dismissed. If you present proof of purchase of a 6 month current insurance policy and a copy of your MVD record showing no convictions for violating A.R.S 28-4135 within 24 months prior to the date the complaint was issued, or only one conviction for violating A.R.S 28-4135 within the 36 months prior to the date the complaint was issued the total amount due may be reduced to \$226.00. If you are unable to provide proof of insurance for the DATE and TIME the complaint was issued, you must come to court on or by your court date.

#### **DIVERSION CLASS**

If you have been cited for a City Code or Title 28 Moving violation, while traveling as a pedestrian or while operating a bicycle or electric scooter, you may be eligible to attend a Diversion Class instead of paying the fine. If your complaint contains more than one charge, you must select a different option for those violations on or before the appearance date on the bottom of the complaint. This diversion course can only be used to have one violation dismissed per rolling year (as counted from the date of one violation to the date of the next).

#### ADVANTAGES:

- 1. That charge will be dismissed.
- 2. You will not have to pay the fine for that charge.

## WHAT TO DO:

- 1. Pay a \$50.00 Diversion Fee and retain the receipt.
- 2. Visit the Tempe Police Department website at <u>https://www.tempe.gov/diversion</u> to register and complete the diversion class.

Failure to complete the diversion class AT LEAST SEVEN BUSINESS DAYS PRIOR to your court date may result in additional monetary penalties being imposed.


