Agenda Item 3 - Update: Arts & Culture Division

- Brendan Ross, Deputy Director for Arts & Culture,
 - The Arts & Culture Division is currently rolling out the supplemental approvals for FY23. There will be a range of new supplemental requests submitted for FY24 to further enable the division to accomplish goals stated in the 2015 Arts & Culture Plan and 2019 AMS Recommendations.
 - Arts & Culture marketing efforts:
 - There has been more investment in marketing for programs other than TCA.
 - Tempe Center for the Arts

- Currently reviewing the calendar for the forthcoming two years and looking at how to continue to attract and concentrate arts and culture activities.
- Continuing to support the range of stakeholders who use TCA for community good.
- A central priority of TCA is the arts and culture content and achieved in three ways:
 - The work we create ourselves and put on stage
 - The work realized through partnerships resulting in mutual investment (such as with resident companies)
 - Attracting external rental clients who bring programs to TCA
- TCA working to refine a programmatic strategy that will focus on how to continue to get leverage out of the supplementals that have been supported, including new staff, and converting that to programmatic outcomes.
- To fill out the arts and culture ecosystem, there is a particular focus on partnerships:
 - with resident companies in an effort to gather information on how to best support their growth and sustainability.
 - with new artists or organizations to encourage success through a mix of small, medium, and large activity.
 - with large organizations to bring critical mass to Tempe events and as a result to other local shops, restaurants, and venues.
- Commissioner comments:
 - They appreciate the reliability of regular events such as Walk in Wednesday and the former Edge Happy Hour. It's a great way to see local talent and to be a part of the TCA energy when other events are also happening in the Theater or Studio.

Agenda Item 4 - Update: Commission Membership

- Robert Nichols has resigned as a TACC member. City Council will vote in a new member at the November meeting to fill this vacancy.
- Jeff Davis will not be returning to TACC in 2023.
- We must continue to promote the opportunity to join the Arts & Culture Commission.
 - O Commissioner comments:
 - TACC and the Arts & Culture Division should be present at major events to initiate conversations about the arts and opportunities to be involved.
 - Post opportunities on social media
 - Commissioners send out emails/messages to their network
 - Commissioners wear name badges when attending Tempe Arts & Culture events
 - Add blurbs about TACC to event and show programs
 - Schedule commissioners to attend events

Agenda Item 5 - Update: IDEA Campus

M. Kobierowski, updated TACC about a recent meeting she, Jeff Davis, and Brendan Ross attended with an attorney for Boyer and a design representative for the next phase of the development:

- Expansion of IDEA Campus is in an exploratory phase
- Thoughts from IDEA Campus representatives:
 - o Infuse public art in the building design
 - o Create an arts incubator space
 - o Include rehearsal and collaborative space
 - Create an outdoor amphitheater for live performances
 - o Include residential units as opposed to a hotel

TACC discussion:

- Architecture is not a continually contributing public amenity
- The original IDEA Campus plan supplied public amenity; this should be upheld
- Incubator studios spaces should be visible
- Public art around TCA should be interactive
- Creative residency through award program

- Finding the right fit for prime real estate lakeside
- There is high value in a hotel and a restaurant as a compliment to the theater
- Artists seek out art friendly hotels; there are opportunities to showcase art in hotels
